On dated 21.08.2022 at about 0735hrs, a lady pax namely Anila Bhutia travelling by Air Asia flight No 15-1781 Bagdogra to Bangalore with Ticket PNR KTP37 dated 21-08-2022 entered Airport Terminal Building through Departure Entry by showing Air ticket and valid ID card. After entering the terminal building, the lady pax wanted to exit from the Terminal building with the pretext that she had left some documents in hotel.

02. On query, it reveals that the lady pax having booking on 24.08.2022 in flight No-15-1781(Bagdogra to Bangalore) with PNR KTP37Y. It is also reveals that she do not have any flight booking on 21.08.2022. It is pertinent to mention here that above lady pax entered Airport Terminal Building with fake and edited air ticket, which is serious security breach in aviation security and her motive is not known and it is an offence under U/S 465, 468 & 471 of IPC.
