I, Shirsande Karmakar, son of Lt. Sailendra Karmakar, residing in Airport More, Bagdogra was assaulted by multiple person in Bhuttabari today at 7pm.

I was on my way to Mr. Amit Ghosh's farm in Bhuttabari for some official business around 7 pm when I crossed the road and started going toward Bhuttabari, a stone hit my car. I stopped my car to see a man running towards my car. The man came to my car and started shouting. He said my car hit him. I argued how can it be true if he is running. At this he pulled my Tshirt and hit me on my nose. I said I will call police. At this, ~~they~~ few more guys came and pulled me out of my car & started hitting me.

They used a metal/steel pipe & sticks to hit me. I am badly injured. They kept saying me to call police while hitting me.

They said I am intoxicated that is why these 10-15 people were hitting me. But I was not under the influence of alcohol or any other thing.

The medical report is attached, please take strict action. The person who started this is named Prashant. The owner of the book store in Bhuttabari more was the one who was threatening & hitting me for asking to call Police. He and others with him attacked me.

Please take strict action against all offenders.
