Subject :-Intimation regarding a fatal accident of Alphaj MD S/O: MD Rafik for carrying out unauthorized activity in close proximity to 11KV HTOH line in the premises of Umesh Sah, Airport More, Masjid Para, Bagdogra, Darjeeling on 22.08.2022 at around 02:16 PM under Siliguri Sub-Urban Division.

Sir

I, Anil Kumar Kisku, S/O Talababu Kisku posted as Assistant Engineer(E) at Siliguri Sub-Urban Division would like to inform you that on 22.08.2022 a fatal electrical accident occurred near Airport More Masjid Para opposite SBI Bank, Bagdogra at around 02:16 PM where Alphaj MD(Male), Age 25(approx) got electrocuted. The incident as reported by LT mobile van of Bagdogra CCC & local residents occurred while performing civil/construction work in the premises of Umesh Sah, Airport More, Masjid Para opposite SBI bank, Bagdogra, Darjeeling.

As gathered from the local public, the victim was performing construction work in the premises of Umesh Sah, where while lifting a piece of iron rod to the terrace of the building he came in close contact with the live line(Bagdogra 11KV Feeder-NBU Substation)leading to electrocution of the victim. After getting electrocuted victim falls on the terrace .

It may be stated here such kind of activity of working in the close vicinity to our live lines is totally unauthorized & condemnable by law. As the work was being carried out in such a casual manner, such incident would have been taken place. Such kind of mal practices leads to accidents. Hence you are requested to take necessary action accordingly. Thanking you.
