With due respect I the undersigned would like to inform you that I along with Sri Subal Chandra Roy, S/o. Sri Phanindra Nath Roy, of Fakdaibari, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalpaiguri and Smt. Beauti Rani Roy (Barman), W/o. Sri Jyotish Roy Barman of Binnaguri, Kamat Para, P.O. Sahudangi Hat, P.S. NJP, Dist. Jalpaiguri have purchased a piece of land measuring about 1.5 Bigha recorded in R.S. Khatian No. 2780, R.S. Plot No. 316, 317, 317/841, 341, 317/842, Mouza - Binnaguri, P.S. Bhaktinagar now NJP, Dist. Jalpaiguri by virtue of registered Deed of Sale being instrument no. 4696 of 2015. Thus I became the 1/3rd undivided share holder of the said landed property. I would like to further inform you that very recent the said other co-owners Sri Subal Chandra Roy and Beauti Rani Roy (Barman) have tried to sale the entire piece of land against the valuable consideration to some stranger with an intention to deprive me and for that I was compelled to file suit for partition being Title (Partition) suit No. 172/2022 before Ld. Civil Judge Senior Division, Jalpaiguri and Ld. Court was pleased to pass an injunction order on 03.08.2022 directed to maintain Status Quo in respect of the nature, character of the possession and in respect of the alienation of the said landed property till 03.09.2022. I would like to further inform you that after getting the knowledge of the order of the injunction dated 03.08.2022 as passed by the Ld. Court, I got an information that said Subal Chandra Roy accompanied with some unknown persons have tried to measure the land again on 20.08.2022 with an intention to sale the same and getting such information I rushed to the land but said Subal Chandra Roy and his said associates have resisted me from entering into the said landed property on 20.08.2022 and on protest said Subal Chandra Roy pushed me on the chest of my private part and for that I failed down on the earth and sustained injury in my west and
