Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Rajat Mahato (28) s/o Lallan Mahato of South shantinagar, PS- NJP, Dist.- Jalpaiguri (ii) Md. Raju (30) s/o Md. Akhlum of South Colony, PS- NJP, Dist.- Jalpaiguri (iii) Mithun Roy (34) s/o Pranab Roy of Mamtapara, PS- NJP, Dist.- Jalpaiguri and (iv) Ajay Biswas s/o Mukul Biswas of Jorpokheri, PS- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

- 1 One iron made sharp cutting weapons called as Hasua and one torch light and one screw driver (approx 15 inch) from the possession of accused Rajat Mahato (28) s/o Lallan Mahato of South shantinagar, PS- NJP, Dist.- Jalpaiguri
- 2 One iron made sharp cutting weapons called as Bhojali from the possession of accused Md. Raju (30) s/o Md. Akhlum of South Colony, PS- NJP, Dist.- Jalpaiguri
- 3 One sharp cutting knife and one torch light from the possession of accused Mithun Roy (34) s/o Pranab Roy of Mamtapara, PS- NJP, Dist.- Jalpaiguri
- 4 One Iron rod and one torch light from the possession of accused Ajay Biswas s/o Mukul Biswas of Jorpokheri, PS- NJP, Dist.- Jalpaiguri

I, PSI-Newton Biswas of NJP PS, Siliguri Police Commissionerate beg to state that on 23.08.2022 at 02.15 hrs received a secret source information that that a gang of miscreants come at near Mamtapara, PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Mamtapara and Rajib Nagar area. Accordingly, I diarised the fact in General Diary vide NJP PS GDE No 1115 dated 23.08.2022 and informed the fact to you as well as Asstt Commissioner of Police, East-II, SPC about the information. I also informed the fact to night RT Van officer and requested them to come to Mamtapara to accompany with us. At 02:35 hrs. we arrived at Mamtapara near Toto Stand under PS- NJP, Dist.- Jalpaiguri and ambush there. After a few time RT Van officer along with force came to near Mamtapara and accompany with us. At about 03:45 hrs as indicated by the source we noticed that 10/11 persons assembled in a dark place at Mamtapara besides Mamtapara Totostand, PS- NJP, Dist.- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 04 (four) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Mamtapara Area and Rajibnagar area. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 04:05 hrs to 04:45 hrs on 23.08.2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Rajat Mahato (28) s/o Lallan Mahato of South shantinagar, PS- NJP, Dist.- Jalpaiguri (ii) Md. Raju (30) s/o Md. Akhlum of South Colony, PS- NJP, Dist.- Jalpaiguri (iii) Mithun Roy (34) s/o Pranab Roy of Mamtapara, PS- NJP, Dist.- Jalpaiguri and (iv) Ajay Biswas s/o Mukul Biswas of Jorpokheri, PS- NJP, Dist.- Jalpaiguri and others and arrange for its investigation.
