In producing herewith the arrested One Lady accused persons namely Kamana Sarkar (23) w/o Parimal Sarkar of Dakshin Veveknanda Pally, PS-Kotwali, Dist.- Jalpaiguri A/P Asigarh Bazar, PS-Ashigarh OP, under Bhaktinagar PS, Dist.- Jalpaiguri (Not verified) along with the following seized articles under proper seizure list:-

Total 01(One) numbers of plastic packet containing Total 0.261 Kg (Two Hundred and Sixty One Grams] Approx of suspect to be Brown Suger Marked as follows:

- (i) One packet of Plastic containing 0.261 Kg [Two hundred and Sixty One Grams] of suspect to be Brwon sugar kept in Red Color Polythene marked as Exhibit-"A".
- (ii) One Blue and Black Color Bag style as Skybag.
- (iii) One Red Color Polythene.

I, SI Pradeep Diyali of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted One (01) arrested lady accused persons to the effect that today 23.08.2022 at about 1345 hrs I received a specific source input that One (01) Lady were standing at Noukaghat More near Mahananda Bridge with huge quantity of Brwon Suger for delivering the same to their designed customers. The matter was diarized vide NJP PS PS GDE No. 1138 Dt. 23.08.2022 and I informed the matter to SI Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri Police Station in writing a letter to him and expressed the entire information. As per his kind direction myself along with other officers and force named ASI Sajal Das, LC/1328 Sangita Maley, VP/08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, Siliguri Police Commissionerate being headed by me left for Noukaghat near Mahananda Bridge by govt, vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 1139 dated 23.08.2022 and M.C.C. No. 1616/22 dated 23.08.2022. In the mean time I also informed the Videographer namely Tapan Mandal s/o Testo Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Noukaghat to prepare the Video of whole process of search and seizure if any. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender. At about 1405 hrs we arrived at Noukaghat near Mahananda Bridge and on the way to the spot, I called two independent witnesses namely (i) Sukamalsen Gupta s/o Lt. Subirsen Gupta of Shaktigarh Road No.- 03, PS- NJP, Dist.- Jalpaiguri (ii) Saumiya Bikash Ghosh @ Babai s/o Lt. Jyoti Prakash Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as witnesses under relevant provision of law. After arrival at the spot and as identified by the source we found that 01 (one) lady were sitting at Noukaghat Near Mahananda Bridge in front of Office of the Executive Engineer, under PS- NJP, Dist.-Jalpaiguri which was matched with our information. Accordingly, we intercepted the above a Lady who disclosed her identity as noted above.

After disclosing our identity, we detained the above noted lady with a strong reason to believe that she illegally possessing brown Sugar in their possession which she is carrying for selling the same to their designed customers for their wrongful gain. On being asked she confessed that she possessed brown Sugar in her possession. I then gave her option in writing whether she wanted to be searched in presence of Executive Magistrate or by any Police Gazetted Officer. Then she agreed to be searched by any one of them. Further, I served her a notice in accordance with provisions of law in this regards. I also offered the independent witnesses and the apprehended persons and lady to search our Police Party as per provision of law but they denied to search police party. Accordingly, I informed the matter to the Officer-In-Charge, NJP PS and as per his kind order I informed the fact to Shri Pasang Tobgey Bhutia, Assistant Commissioner of SPC for the day regarding the interception of the lady accused persons suspected to be possessed of Brown Sugar and requested him to come to the spot and to supervise the search and seizure being a gazette officer. Accordingly at 1415 hrs Shri Pasang Tobgey Bhutia, Assistant Commissioner of Police, Traffic East, Siliguri Police Commissionerate arrived at the spot and accordingly, I disclosed his identity to the detained persons as Special Executive Magistrate of Siliguri Police Commissionerate.
