In producing herewith one arrested accused person namely Minoti Adhikary (40yrs), W/o Anil Adhikary of Farabari, Velkipara, P.o-Sahudangi Hat, PS-NJP, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12(Twelve) sealed bottles of 60 Up Country Sprit each bottle containing 600 ML.

1. ASI. Uday Sankar Bhattacharjee of Ambari Falakata Out Post under NJP PS/SPC lodged a written complainant against the above noted accused person to the effect that today on 23.08.2022 at about 16.10 hrs received source information that one person has gathered huge amount of liquor illegally and selling the same to the local customer at Farabari, Velkipara for her wrongful gain. This refers to Ambari Falakata out Post GDE No. 831 dated 23.08.2022. Therefore, I conveyed the same to O/C Ambari Falakata Out Post and as per his instruction I along with 1) L/C-1376 Leela Roy (2) LCV/053 Gopa Biswas and (3) NVF-0036 Ananda Sharma all of Ambari-Falakata OP, Under NJP PS/SPC proceed to Farabari, Velkipara to work out veracity of the information. At about 16.30 hrs we have reached at the spot and being identified by the source our police party held raid at Farabari, Velkipara in presence of two independent witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chaklavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Pranab Chowdhary S/o. Lt. Balai Chowdhary of 09 No Colony, PO. Ambari-Falakata, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and recovered (i) 12(Twelve) sealed bottles of 60 Up Country Sprit each bottle containing 600 ML, from the possession of a. cused person namely Minoti Adhikary (40yrs) W/o Anil Adhikary of Farabari, Velkipara, P.O-Sahudangi Hat, PS-NJP, Dist-Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same to the local villagers since long for her wrongful gain. Accordingly, I have seized the above noted articles under proper seizure list in presence of above noted witnesses and took signature of the accused person and witnesses. The seizure was made in between 16:45 hrs to 16:50 hrs. Therefore, I have arrested the said accused u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Minoti Adhikary (40yrs) W/o. Anil Adhikary of Farabari, Velkipara, P.o-Sahudangi Hat, Ps-NJP, Dist-Jalpaiguri under proper section of law.
