Sir,  
In producing herewith four arrested accused persons named (1) Kalidas Dey 27yrs s/o Late Manik Dey R/o near Samar Biri Factory Arobindopally Ward No 22 PS, Siliguri. A/p Biswajit Roy Shantinagar Ambedkar Club Ward No 26 PS, Siliguri Dist, Darjeeling (2) Bapi Karmakar @ Patla 40 yrs s/o Sri Nanda Gopal Karmakar R/o near Ramkrishna School Ward No 36, Ghugumali PS, Bhaktinagar Dist, Jalpaiguri (3) Md Alam 45yrs s/o Md Alauddin of Gowalapatty Ward No 04 PS, Siliguri Dist, Darjeeling (4) Ashok Routh 29yrs @ Choto Banghta s/o Ram chandra Routh R/o Tikiapara Matongini Colony Ward No 28 PS, Siliguri Dist, Darjeeling along with seized articles (i) One knife measuring 12" including handle from the possession of Kalidas Dey 27yrs which was kept concealed on the back side of his waist and one three sell torch light (ii) One sharp cutting weapon (Bhojali) measuring approx 15" including its handle from the possession of Bapi Karmakar @ Patla 40 yrs which he was holding on his hand (iii) One iron rod measuring approx 23" recovered from the possession of Md Alam 45yrs which he was holding on his right hand (iv) One hand made Daw measuring approx 13" including its handle and one nylon rope recovered from the possession of Ashok Routh 29yrs @ Choto Banghta under proper seizure list.

I, SI Bapi Ch Dey of Panitanki TOP (Under Siliguri PS)/SPC do here by lodge this written complaint to the effect that on 24.08.2022, at 00.35 hrs, I received secret source information that 7-8 persons had assembled below the Mahananda bridge at Makhakalpally area to commit Dacoity on that locality. Immediately informed the tip of information to O/C Panitanki TOP, and IC Siliguri PS, and noted the fact in GD vide Panitanki TOP GDE No 541 dt.24.08.2022 and as per their kind instruction then and there, I along with ASI Biswajit Ghos, ASI Ratan Kr Ghosh, C/702 Latifur Rahaman, C/1036 Gopal Srivastav, CV/377 Dinesh Roy, CV/1007 Jiten Roy left for back side of Surya Sen Park near Mahananda river to verify the veracity of the information without any delay. At about 03.10 hrs, I along with police party reached at the spot ie and parked the vehicle in a distant proceeded towards Mahananda bridge Mahakalpally on foot and being indicated by the source we found from the considerable distance that a gang approx of 7/8 persons were assembled below the Mahananda bridge at Makhakalpally area and they were whispering in very low voice. Due to night, I search local persons for remain present during search and seizure as independent witness but none person shown nearby by the spot. Accordingly, we cordoned the place and approach towards them. But seeing the presence of police party, they scattered in multi direction and start to flee away from the spot but after a hot chase we manage to apprehended (04) four persons and others 3/4 persons were able to fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 3/4 persons were assembled there in preparation to commit Dacoity at Dasarath Pally and adjacent area. Accordingly, I on being search in presence of the police witnesses the following deadly weapons was recovered ie (i) One knife measuring 12" including handle from the possession of Kalidas Dey 27yrs which was kept concealed on the back side of his waist and one three sell torch light (ii) One sharp cutting weapon (Bhojali) measuring approx 15" including its handle from the possession of Bapi Karmakar @ Patla 40 yrs which he was holding on his hand (iii) One iron rod measuring approx 23" recovered from the possession of Md Alam 45yrs which he was holding on his right hand (iv) One hand made Daw measuring approx 13" including its handle. Accordingly, I seized the above noted recovered deadly weapons as under proper seizure list in presence of witnesses and duly signed by the accused as well as witness in between 00.50 hrs to 01.20 hrs, on being asked they failed to produce any satisfactory replied. Accordingly, I arrested them U/S 41 Cr.P.C issued memo of arrest and inform them their ground of arrest.


Under the above fact and circumstances, I pray before you that a specific case may kindly be started against (1) Kalidas Dey 27yrs s/o Late Manik Dey R/o near Samar Biri Factory Arobindopally Ward No 22 PS, Siliguri. A/p Biswajit Roy Shantinagar Ambedkar Club Ward No 26 PS, Siliguri Dist, Darjeeling (2) Bapi Karmakar @ Patla 40 yrs s/o Sri Nanda Gopal Karmakar R/o near Ramkrishna School Ward No 36, Ghugumali PS, Bhaktinagar Dist, Jalpaiguri (3) Md Alam 45yrs s/o Md Alauddin of Gowalapatty Ward No 04 PS, Siliguri Dist, Darjeeling (4) Ashok Routh 29yrs @ Choto Banghta s/o Ram chandra Routh R/o Tikiapara Matongini Colony Ward No 28 PS, Siliguri Dist, Darjeeling and 3/4 others under proper Section of law and arrange for its investigation.


