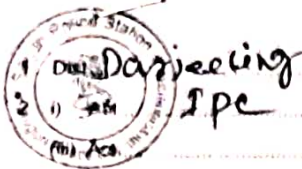

Sir,

I, Smt. Paramita Paul, daughter of Sri Goutam Paul and wife of Sri Debabrata Sarkar, Presently residing at Rishi Aurobinda Road, Hakimapara, Ward No. 12, P.O. & P.S. Siliguri, District Darjeeling, would like to write you for the following effect,

That I was married to Sri Sri Debabrata Sarkar on 14.05.2017 at the ancestral home of my husband at Kadambini Tea Estate, P.O. Falakata, Dist. Coochbihar, and on 28/02/2021, and after prolonged physical and mental torture upon me by my husband, Debabrata Sarkar, he forced me out of his house after abusing me with slang, assaulting me, and also after assaulting our daughter, who at that time was only 1.5 years old.

That I narrating the all the details of the torture inflicted upon me had filed a complaint before the Siliguri Women Police Station on 17/10/2021, and a specific case was stated on the basis of my said complaint, being Siliguri Women P.S. Case Number 160 of 2021, under sections 498A/307/206 of the Indian Penal Code. I also had filed a petition under the Domestic Violence Act, before the Ld. A.C.J.M. at Siliguri, being Number Misc. Case Number 12 of 2022.

That even though after filling both the complaints he is still continuing his torture upon me, he follows me each and every time I get out of my house,
