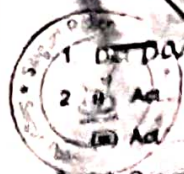

Sir,
I, Shankar Adhikary (26), the above named, complainant beg to inform you that Dt. 23.08.2022 at about 06.00 am, when my uncle namely, Putun Gupta s/o Lt. Nanda Kishore Gupta, resident of Goshakar Adhikary, Sekhar line Hotel, Ghoshpukur (Near Toll Plaza), P.S. Bidhan Nagar, Dist. Dajebly, reached at Burdwan Road, Air View More, sitting on an Ashoke Leyland Truck, front seat behind driver of said Truck, bearing Regd. No MH-12M-V-4894, and when my said uncle guided said driver to turn left but said driver turned the vehicle, in the right side as a result the said truck, driven by said unknown driver in rash & negligent way, hit the said truck on newly constructed flyover, and then said truck was badly-damaged and the left hand side front glass broken and my said uncle namely Putun Gupta's body came out from the said front glass and fell on the flyover's under constructed railing, and he received severe injury on his person, he immediately shifted to Siliguri Dist. Hospital and admitted there, in very serious condition, and his health conditions are very very bad, and anything happen to him. So, please take necessary action against said offensive vehicle, bearing Regd. No MH-12M-V-4894 and its unknown driver.
