I, Ranjit Kr. Paul, SI of Police, OC, Panitanki TOP Under Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the 01 (One) arrested accused person namely Amit Shil (M/28), S/O Lt. Ramesh Shil of Nirmal Nagar Colony, near Maya Devi Club, PS-Matigara, Dist-Darjeeling and Rajesh Kumar Singh owner of "ELITE" Salon situated at 3<sup>rd</sup> floor of M Bazar, Sevoke Road to the effect that on 25.08.2022 at 17.10 hrs received a secret information from source that some prostitution business is going on at different salons at M Bazar, Sevoke Road under Siliguri PS Dist: Darjeeling under the coverage of body massage. Accordingly, the information was diarized vide Panitanki TOP GDE No- 536 Dated 25.08.2022 and myself along with SI-Bapi Ch Dey, SI Rana Brahma, ASI Biswajit Saha, ASI Surojit Mallick, Const-576 Binoy Ch Roy, Const-984 Subhasish Das, CV-1009 Manoj Thakur, LC-575 Panchami Roy, LCV-1023 Basanti Singha all of Panitanki TOP under Siliguri PS/SPC and SI Basudev Guha, ASI- Siben Sarkar, ASI Rabin Lama, ASI Debasish Das, L/C-186 Anisha Biswakarma and L/C-176 Parbati Barman all of Siliguri PS/ SPC left for M Bazar, Sevoke Road under Siliguri PS to verify the veracity of information. On arrival at M. Bazar, Sevoke Road under Siliguri PS, I called two available local independent witnesses namely (1) Sushanta Das (M/28), S/O Gobinda Das of Dadupur, PO+PS-Nakashipara,

Dist- Nadia A/P work at Star Nails (City Mall), residing at Salugara, Dem Dema Busty, PS-Bhaktinagar, Dist-Jalpaiguri and 2] Narayan Halder(M/26), S/O Niranjan Halder of Bhirpur Ghat, PS- Nakasipara, Dist- Nadia A/P work at Star Nails (City Mall), residing Salugara, Dem Dema Busty, PS-Bhaktinagar, Dist-Jalpaiguri and requested them to remain present during the time of raid, search and seizure if any. Subsequently, we entered into the shop styled as "ELITE Salon situated at the 3rd floor of M Bazar, Sevoke Road. We disclosing our identity and found two female was present inside the salon, On being asked they disclosed their identity as 1] Sushmita Roy (F/32), W/O Sunil Roy of Village- Kadamtala, PS- Jalpaiguri, Dist- Alipurduar and 2] Puja Sarkar (F/25), W/O Rabi Sarkar of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling and also stated that they are working in the said salon, on further asked they are finally stated that they engaging in the business of prostitution in the said salon for livelihood and earn money . Then we started searching the said salon and found two small rooms made for customers for sexual act and the said room of the Salon was partly closed from the inside. Then we knocked the door of the room and when opened, we found one male and female person inside the room in an objectionable position (i.e., almost nude) and were involved in sexual activities. Seeing Police presence, they hurriedly put on their clothes. Thereafter with the help of lady Police we separated the female from the male person and being asked by me the female person disclosed her name as Pinki Roy(F/29), W/O Goutam Roy of Jagirebari, PO+PS-Mainaguri, Dist- Jalpaiguri and further she disclosed that she has been engaging in the business of prostitution by the owner of "ELITE" Salon namely Rajesh Kumar Singh and also added that she is unaware about the exact location of his residence and she was indulged in the business of prostitution for her livelihood and earn money. Thereafter we took the victim into our safe custody. Further interrogation said male person disclosed his identity as Amit Shil (M/28), S/O Lt. Ramesh Shil of Nirmal Nagar Colony, near Maya Devi Club, PS-Matigara, Dist-Darjeeling and he admitted that he was came this salon for his sexual pleasure in lieu of paying money to the owner of the Salon.

Further enquiry it is learn that the owner of the salon style as "ELITE" Salon has been carrying the business of illegal prostitution under the camouflage of Body massage in a public place (shopping Mall Complex) for their monetary benefit and maintain their livelihood on the money which they earn through the business of prostitution under the camouflage of Body massage. Accordingly, we searched the "ELITE" Salon in presence of independent witnesses and found above noted articles and seized under proper seizure list. Subsequently, I searched for the owner of ""ELITE" Salon but could be found his whereabouts. Then, I arrested the accused namely Amit Shil (M/28), S/O Lt. Ramesh Shil of Nirmal Nagar Colony, near Maya Devi Club, PS-Matigara, Dist-Darjeeling u/s 41 Cr.P.C observing all formalities. And the victim girls namely 1] Pinki Roy (F/29), W/O Goutam Roy of Jagireban, PO+PS-Mainaguri, Dist- Jalpaiguri, 2] Sushmita Roy (F/32), W/O Sunil Roy of Village- Kadamtala, PS- Jalpaiguri, Dist- Alipurduar and 3] Puja Sarkar (F/25), W/O Rabi Sarkar of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling taken into our safe custody under proper lady escort. And I brought them to Siliguri PS.

Hence, I would like to request you that a specific case under proper sections of law may please be started against accused person namely 1] Amit Shil (M/28), S/O Lt. Ramesh Shil of Nirmal Nagar Colony, near Maya Devi Club, PS-Matigara, Dist-Darjeeling and 2] Rajesh Kumar Singh owner of "ELITE" Salon and arrange for its investigation.
