
JHUMA PRAMANIK, W/O - Litan Pramanik, Presently residing at
Kawakhali, P.O. Shusrut Nagar, P.S. Matigara., Dist. Darjeeling, do hereby
want to inform you that :-

1. That I lodge this F.I.R to the effect that on **15.12.2010**, I was married to
Litan Pramanik, S/O - Late Sribash Pramanik, Permanent resident of
Kawakhali, P.O. Shusrut Nagar, P.S. Matigara., Dist. Darjeeling.

2. That during the marriage negotiations, my husband's family members
demanded wardrobe, Dressing Table, Bed etc including all the household
articles and cash dowry of Rs. 2,00,000/- from my father. Moreover in this
regard I would like to inform you that my husband's family members
specifically told my father that all the demanded articles along with cash
dowry of Rs. 2,00,000/- (Rupees Five Lakh Only) must be given to them
prior to marriage ceremony and subsequently as per the demand of my
husband's family members, my father has given all the above mentioned
articles along with cash dowry of Rs. 1,00,000/- (Rupees One Lakh Only)
and gold ornaments worth Rs. 4,00,000/- (Rupees Four Lakh Only) to my
husband, in presence of the other relatives.

3. That subsequently after my marriage I started my conjugal life at the
matrimonial house at Kawakhali, P.O. Shusrut Nagar, P.S. Matigara., Dist.
Darjeeling.

4. That soon after marriage my mother-in-law namely 1) **DIPTI PRAMANIK**,
W/O late Sribash Pramanik, 2) **SMRITI PAUL (PRAMANIK)** (Sister-in-law),
3) **BINOY PAUL** (Husband of Smriti paul), started to torture me both
mentally and physically and pressurized me to bring money from my parental
house and when I refused to comply their demands my above named in-laws
bang my head on the wall by putting towel into my mouth so that I cannot

scream. Moreover, my above named in-laws always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my above named in-laws was never happy with me and always used to taunt me as I had brought insufficient dowry. I was treated like a servant from the very beginning. I was bearing all the torture of my above named in-laws with a hope that everything will be alright in future but everything was in vein.

5. That subsequently I got pregnant in the end of 2011 and during that period the above named accused persons increased their torture level by way of giving less quantity of food and removed the servant from the house and forced me to do all the household works and when my husband protested their inhuman behavior my mother in-law started hue and cry to prove that my husband want to kill her in front of the neighbours and also threatened my husband that if he protest against their acts and conducts then they will implicate my husband in false cases.
6. That subsequently I became sick and my husband took me to the Doctor and on 01.07.2012 I gave birth to a female child and after the birth of a female child , my mother-in-law namely 1) **DIPTI PRAMANIK**, W/O late Sribash Pramanik, 2) **SMRITI PAUL (PRAMANIK)** (Sister-in-law), 3) **BINOY PAUL** (Husband of Smriti paul) started to abuse me with filthy languages for giving birth of a female child and took various attempts to kill my infant baby and me by way of leaking the gas cylinder pipe as and when I open the gas oven I and my infant child may burn into the fire.
7. That thereafter in the month of February 2021 due to the constant mental and physical torture of the above named accused persons, specially **SIMRITI PAUL (PRAMANIK)** (Sister-in-law), who is a working a ICDS, and her son namely Abhijeet Paul, who used to abuse me with filthy languages and when I protested as a guardian the said Abhijeet Paul, S/O Binoy Paul, slapped me and kicked me in my abdomen upon the instigation of his mother **SMRITI PAUL**, I suffered a severe Brain Stroke but the above named accused person did not bothered to take me to a Hospital, rather they left me in dyeing situation and when my husband came to house and rescued me and took me to the Hospital.

8. That subsequently from the month of May, 2022, I again got pregnant and when I told my husband and his family members about my pregnancy, I found that my above named in-laws became very aggressive also told me they could not maintain this unborn child and forced me to abort the unborn child and when I refused to do so my above named in-laws started to torture me both physically and mentally and most of the time I was forced to do all house hold works intentionally which was very much risky at the earlier stage of pregnancy, slapped me hardly, and kicked me at my back with an intention to kill my unborn baby but due to the constant care and protection of my husband I am still alive.
9. That on 13.08.2022 I visited the Doctor for my routine check-up and the concerned Doctor advice me to take rest but my above named in-laws tried to give me various medicine only with the intention to kill me and my unborn baby but I was always being saved due to my own alertness my above named in-laws are solely responsible for their inhuman torture and physical assault and for which my above named in-laws should be punishable on the eye of law
10. That my above named in laws are so cruel that they never ever take care of me my above named in laws continuously threatening me and used to abate me to commit suicide and the sole intention of my above named in-laws was that due to the continuous mental torture I became bound to commit suicide.
11. That my above named in-laws tortured me throughout the day at night mentally and physically by abusing me and my family threatening to kill me and if I tried to protest they slapped me and kicked me and hit me with fist and blows and threatened to burn me to death if I did not go away.
12. That at present I am living in very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my mother-in-law namely 1) **DIPTI PRAMANIK**, W/O late Sribash Pramanik, 2) **SIMRITI PAUL (PRAMANIK)** (Sister-in-law), 3) **BINOY PAUL** (Husband of Simriti paul), 4) Abhijeet Paul (Son of Binoy paul).

I therefore request before your good self to kindly look into the matter and take necessary action against my mother-in-law namely 1) **DIPTI PRAMANIK**, W/O late Sribash Pramanik, 2) **SIMRITI PAUL (PRAMANIK)** (Sister-in-law), 3) **BINOY PAUL** (Husband of Simriti paul) 4) **ABHIJEET PAUL** (Son of Binoy paul) all are resident of Baghajatin Colony, Opp. Mutka Moncho, ward No. 02 of S.M.C., P.O. & P.S. Pradhan nagar, Dist. Darjeeling, as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
