In producing herewith three (3) accused persons namely 1. Krishna Sarkar (26) s/o Bimal Sarkar of Tetultala, Rangapani PS Bagdogra, Dist. Darjeeling 2. Sushanta Paul (27) s/o Thakur Das Paul of Palpara, Rangapani PS Bagdogra Dist. Darjeeling 3. Biplab Barman (24) s/o Dinesh Barman of Sahapara, Ranidanga PS Bagdogra Dist. Darjeeling along with seized articles viz

1. One iron made "Katari" having approx length 15 " inches including butt from the possession of accused Krishna Sarkar.
2. One Knife having length approx 12" inches including butt from the possession of accused Krishna Sarkar
3. One iron rod having length approx 04 feet from the possession of accused person Sushanta Paul
4. One iron made "Sabal" measuring approx 3 ½ feet from the possession of accused person Biplab Barman
5. One electronic Torch light from the PO.

I SI Upendra Nath Roy, Bagdogra PS, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 24.08.22 at 00-05 hrs received a secret source or information to the effect that 09/10 miscreants armed with deadly weapons assembled in a dark place at Bharat Singh Jote near Shamshan Ghat under Bagdogra PS with a view to commit dacoity. Accordingly without waste any time I informed the matter to you and directed the matter vide Bagdogra PS GDE No. 1134 dt. 24.08.22 and as per your kind instruction myself alongwith SI Lawang Bomzon ASI Sadananda Debnath, ASI(AB)-61 Raju Roy, C/780 Achintya Singha, C/621 Pradip Kapasi and also night van officer and force ASI Ashish Karmamar CV-385 Amrit singha CV-133 Kartick Das left from PS for Bharat Singh Jote to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 00-30 hrs and stopped out vehicle at a considerable distance from that place and we started walking towards Shamshan Ghat and found a group of 09/10 persons assemble and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang see the police. Somehow, after a hot chase we could able to apprehend the 03 (three) persons noted above and the others 06/07 persons managed to flee away from the spot. On interrogation they disclosed their identity and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Rangapani Bazar under Bagdogra PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession and seized the same as per proper seizure list duly sign by them. Accordingly I arrested the above noted accused person u/s 41 Cr.P.C. The seizure made in between 00-45 hrs to 01-20 hrs and the all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against the above noted 03 (three) accused person and 06/07 other person and arranged for its investigation.
