In producing herewith six(06) arrested accused persons namely (i) Uttam Ray(M/48yrs) S/o- Lt. Ranjan Ray of "D" Block, Leningarh, Chandpur, PS- New Barrackpore, Dist- North 24 Parganas, (ii) Priyalal Acharya (M/58yrs) S/o-Lt. Sitanath Acharya of 38/2 West Kodalia, PS- New Barrackpore, Dist- North 24 Parganas, (iii) Mantu Dutta(M/54yrs) S/o- Lt. Amrita Lal Dutta of Banikantha Nagar, 'A' Block, Kazipara, PS- Barasat, Dist- North 24 Parganas and (iv) Biswa Pradip Bhattacharya(M/57yrs) S/o- Lt. Shyamal Bhattacharya of 136/6, Sharat Chandra Mukherjee Road, Baidyabati, Serampore, PS- Bhadreswar, Dist- Hooghly, (v) Md Bappa (22yrs) S/o- Md Rafikul of Tikiapara, Prankrishna Colony, W/no- 28, PS- Siliguri, Dist- Darjeeling and (vi) Sujit Das (20yrs) S/o- Ranjit Das of Kolabusty near Flower nursery, PS- Matigara, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

- i. One iron made 'Knife' measuring 14 inch (approx) including handle from the possession of Uttam Ray which was kept at his right hand,
- ii. One iron made 'knife' measuring 18 inch (approx) including handle from the possession of Priyalal Acharya which was kept at his left hand,
- iii. One Iron made rod measuring 12 inch (approx) in length from the possession of Mantu Dutta which was kept concealed on his back side,
- iv. Two packet of Hot & Red Chilli powder styled as "Everest Tikhahal" each packet containing 50 grams from the possession of Biswa Pradip Bhattacharya which was kept on his right side pocket.
- v. One Iron rod Crowbar measuring 25 inch in length from the possession of Md Bappa which was kept on his right hand,
- vi. One iron made 'Katari' measuring 24 inch (approx) including wooden butt from the possession of Sujit Das which was kept concealed on his back side

I, ASI Debasish Das S/o- Haripada Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely (i) Uttam Ray, (ii) Priyalal Acharya, (iii) Mantu Dutta, (iv) Biswa Pradip Bhattacharya, (v) Md Bappa, (vi) Sujit Das and others namely Binod, Tepa and Chengu to the effect that today on 26.08.2022 at 00.35 hrs received a source information that 12/14 youths have assembled RAC Club Ground opposite Bagrakote Bus Stand under Siliguri PS with a view to commit dacoity at SubashPally area. The fact was diarized in GD vide Siliguri PS GDE No- 1554 dated 26.08.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per his direction, I along with ASI Rabin Lama, ASI Siben Sarkar, CV/283 Prasanjit Dey and CV/622 Ramanath Barman left for the place to work out the information. On the way to RAC Club ground I informrd K- 21 Van Officer ASI Nayan Kr Das to assist us.

At about 01.05 hrs after reaching Bagrakote Bus Stand under PS- Siliguri I met my source and as pointed by the source we along with K-21 Van Officer and forces started walking towards RAC Club Ground. At 01.25 hrs we reaching RAC Club Ground started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted Six (06) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity at Subashpally and different places of Siliguri area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.45 hrs to 02.35 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrest duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Bagrakote area. It is also revealed from them that Binod, Tega, Chengu and some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Uttam Ray(M/48yrs) S/o- Lt. Ranjan Ray of "D" Block, Leningarh, Chandpur, PS- New Barrackpore, Dist- North 24 Parganas, (ii) Priyalal Acharya (M/58yrs) S/o- Sitanath Acharya of 38/2 West Kodalia, PS- New Barrackpore, Dist- North 24 Parganas, (iii) Mantu Dutta(M/54yrs) S/o- Lt. Amrita Lal Dutta of Banikantha Nagar, 'A' Block, Kazipara, PS- Barasat, Dist- North 24 Parganas and (iv) Biswa Pradip Bhattacharya(M/57yrs) S/o- Lt.
