In producing herewith following seized articles viz (1)Two Broken Sheet of seraut sheet used for beautification of the main gate of Siliguri Municipal Corporation, Sheet No.01 is 12" in length & 6" width and sheet No. 02 is 18" in length & 6" in width, (2) broken guard rail of Siliguri Police Commissionerate white and blue in colour seized under proper seizure list duly signed by the whiteness.

In this regard I, SI Diptajit Dhar presently posted at Siliguri PS, SPC do hereby lodge complaint against 1. Ashok Bhattacharjee of Subhash Pally near Netaji Boys' High School, 2. Ashok Bhattacharjee of Subhash Pally near Netaji Boys' High School, 2. Jibesh Sarkar of Dabgram near Matrisadan Hospital, 3. Saman Pathak under the banner of "Siliguri Pouro Corporation Abhijan".

Subsequently when the rally reached near Siliguri Municipal corporation gate then, under the direct supervision of ACP East-I, SPC, ACP Fulbari ICP, SPC, ACP EB SPC and IC Siliguri PS SPC we stopped the rally near the barricade, outside the main gate of Siliguri Municipal corporation. But the members of CPIM party under the leadership of 1. Ashok Bhattacharjee of Subhash Pally near Netaji Boys' High School, 2. Jibesh Sarkar of Dabgram near Matrisadan Hospital, 3. Saman Pathak, got unruly and tried to break the barricade by using criminal force upon me, other on duty officers and force. Then we started addressing the unruly mob through public address system and tried to negotiate with them in order to keep the Law & order situation normal. But the unruly CPIM members under the leadership of 1. Ashok Bhattacharjee of Subhash Pally near Netaji Boys' High School, 2. Jibesh Sarkar of Dabgram near Matrisadan Hospital, 3. Saman Pathak got more furious and using criminal force upon the on duty police personnel shoved me and others in order to break the barricade and the main gate of Siliguri Municipal corporation. Finding no alternative we

started to push them off and at the same time we were announcing repeatedly through public address system to maintain peace and not to use any criminal force. But the unruly members of CPIM did not pay any heed to our words. They continue to used criminal forced upon on duty police personnel and broke the barricade as well as some part of the main gate of Siliguri Municipal Corporation. Then they entered Siliguri Municipal Corporation premises forcefully and started staging agitation aimlessly. On reinforcement finally we stopped them at the main building gate of Siliguri Municipal Corporation. Thereafter they started to leave the place carelessly and aimlessly leaving the main gate of Siliguri Municipal Corporation in damaged condition & two Police Barricades in damaged condition. Then I Seized the damaged part of (1)Two Broken Sheet of seruut sheet used for beautification of the main gate of Siliguri Municipal Corporation Sheet No.01 is 12" in length & 6" width and sheet No. 02 is 18" in length & 6" in width, (2) broken guard rail of Siliguri Police Commissionerate white and blue in colour.

Now I request you to start a specific case under proper section of law and take proper legal action against 1. Ashok Bhattacharjee of Subhash Pally near Netaji Boys' High School, 2.
