I, S. I. Sudip Dutta, O/C Ashighar OP Under Bhaktinagar PS, lodge this written complaint to the effect that today i.e. on 26.08.2022 morning I noticed that Uttar Banga Sangbad published a news that the land mafias of both sides of Siliguri Eastern Bypass i.e. Naresh More, Jaleshwari, Kankata More, Majhabari Fakdaibari, Bhubesh More & Sahudangi areas threaten the common people those are purchased land at above areas to building up their houses as a result many of them are sold their land in very low rate. The land mafias tactically proposes to the actual land owner, firstly they told to the land owner that if they go to Court they need enough times to get verdict, wherefore if they sold their land to them they will get somewhat money. Those are innocent did not like trouble they sold their land to land mafias as per rate fixed by the land mafias. If someone refuse to sold his land then the land mafias made a Tin or wooden room in the said land and let in a poor family into the said room. Later on to evict the said room and family from the said land they collected heavy amount from the actual land owner. In this way the land mafias of Eastern bypass areas tyrannise on the innocent land purchaser of this area and collected money from them.

Hence, I pray that a specific case may kindly be started over the aforementioned facts and arrange for its investigation.
