- 1. That on 16.7.2021 my marriage was solemnized with my husband and our marriage is a love marriage.
- 2. That since after marriage my father in-law namely Mohan Hela, mother in-law Sushma Hela, and sister in-law Annu Hela started torture upon me both physically and mentally, they compel me to do all house hold works whole day like a servant, they did not provide me food, they did not allow me to come out side from my in-laws house, they locked me in a room whenever they went anywhere, without any reason the above named in-laws always use to abuse me in filthy and offensive languages, my mother in-law always threatened me and insulted me infront of all para people, since 10-15 days my mother in-law threatening me that she would broke my marriage tie with my husband and separate me from my husband, as because I had not brought dowry from my parents house.

3. That today at about 8 a.m. my aforesaid in-laws all of sudden started abusing me in filthy languages and told to leave my in-laws house and told that unless I bring dowry from my father's house they would not allow me to live peacefully and started body shaming me and when I requested them not abuse my in my parents name at that time they started assaulting me and snatched phone from my hands when I tried to call my husband from phone and in assault they torn my wearing apparels and thrown away all my belongings on the road and wrongfully kept all my articles like clothes, jewellery i.e. my finger ring made of silver and ear ring made of gold with them and threatened me that if I do not leave my husband and go away from my in- laws house they would murder me. Anyhow I rescued myself and ran away from there and later my husband knowing this came and helped me.

I, therefore, request to you to kindly take necessary legal action against the aforesaid culprits in the aforesaid matter please.
