Sir,

In producing herewith (06) Six arrested accused persons namely (1) Sanam Gurung-25yrs s/o Monoj Gurung of Sailahat, PS Malbazar, Dist Jalpaiguri (2) Rikesh Tamang-s/o Danil Tamang of Rumtek PS Ranipul, Dist Gangtak East Sikkim (3) Saran Tamang-35yrs s/o Bijay Tamang of Assam Lingzy, PS Ranipul, Dist Gangtak East Sikkim (4) Md Saharuk-24yrs s/o Md Safdar of Asrafnagar near Maszid, PS Bhaktinagar Dist Jalpaiguri (5) Md Samim-20yrs s/o Md Sahimuddin of Asrafnagar, Anchal more PS-Bhaktinagar, Dist Jalpaiguri and (6) Prithibi Sonar-22yrs s/o Madan Sonar of Bhabosindhu colony, Akashbani Radio center, PS Bhaktinagar Dist Jalpaiguri arrested on 27.08.22 u/s- 41 Cr.P.C along with following seized articles viz: -

1. One iron rod measuring about 22 inch (approx) from the possession of accused Saran Tamang which was kept on his right hand.
2. One iron rod measuring about 20 inch (approx) from the possession of accused Rikesh Tamang which was kept on his right hand.
3. One iron made Knife approx 8 inch kept in Tata Sumo vehicle.
4. One Tata Sumo Vehicle having Registration No-SK01J/2386

I, ASI Nitai Mandal s/o Lt Gobinda Mandal of Bhaktinagar Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 27.08.22 at 00.05 hrs received a sources information that 10/12 youths have assembled at a jungle in behind SAI HOSPITAL under Bhaktinagar PS for making preparation to commit dacoity in a house at Bhaktinagar PS area. The fact was diarized in G.D vide Bhaktinagar PS GDE No- 1618 dated 27.08.22 Subsequently after sharing the information with my superiors and as per their direction, at 00.15 hrs myself along with SI Srimanta Chatterjee, SI Sajal Roy, Const/986 Rajib Sarkar, CVF/614 Sumit Kumar Roy, CVF/935 Biplab Roy, CVF/619 Dharmendra Roy, CVF/014 Labannomoy Barman along with kits left for the place to work out the information. Inform night mobile van officer SI D.N.BAkshi with a request to remain present there. This refers to Bhaktinagar PS G.D.E No 1619 dated 27.08.22. We reached at a jungle in behind SAI HOSPITAL, under Bhaktinagar PS at 00.25 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 06 (six) accused persons along with seized articles as

mentioned above. However, the other four persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Bhaktinagar PS area. They also stated that another Four others fled away from the spot and they are came at that place with the seize Tata Sumo.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between 01.20 hrs to 02.10 hrs) Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them.

I accordingly brought the arrested accused persons along with seized article at Bhaktinagar Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit dacoity in a house at Bhaktinagar PS area.

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Sanam Gurung-25yrs s/o Monoj Gurung of Sailahat, PS Malbazar, Dist Jalpaiguri (2) Rikesh Tamang-s/o Danil Tamang of Rumtek PS Ranipul, Dist Gangtak East Sikkim (3) Saran Tamang-35yrs s/o Bijay Tamang of Assam Lingzy PS Ranipul, Dist Gangtak East Sikkim (4) Md Saharuk-24yrs s/o Md Safdar of Asrafnagar near Maszid, PS Bhaktinagar Dist Jalpaiguri (5) Md Samim-20yrs s/o Md Sahimuddin of Asrafnagar, Anchal more PS- Bhaktinagar, Dist Jalpaiguri and (6) Prithibi Sonar-s/o Madan Sonar of Bhabosindhu colony, Akashbani Radio center, PS Bhaktinagar Dist Jalpaiguri and four others and arrange for its investigation.
