Sir,

In producing herewith one accused person namely Nilkanta Roy-35yrs s/o Lt Kamini Roy of Demdema busty, PO Salugara, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10 (Ten) bottles of KINGFISHER strong Beer each bottle containing 650 ML
2. 10 (Ten) bottles of TUBORG strong Beer each bottle containing 650 ML
3. 05 (Five) bottles of MacDowell No.1 XXX RUM each bottle containing 180 ML which was packed in one big nylon bag.

I beg to report that I, SI Srimanta Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one Nilkanta Roy-35yrs s/o Lt Kamini Roy of Dimdima busty, PO Salugara, PS Bhaktinagar Dist Jalpaiguri to the effect that on 27.08.22 at 17.25 hrs received a source information from Demdema busty under Bhaktinagar PS that one person namely Nilkanta Roy has gathered huge quantity of liquor in his house for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Bhaktinagar PS GDE No-1666 dated 27.08.22. As per your kind instruction myself along with force proceeded to the PO to work out the information. At 18.20 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him after maintain all formalities. (The seizure was made in between 18.45hrs to 19.40hrs)

I therefore request you a specific case may kindly be started against the accused person namely Nilkanta Roy-35yrs s/o Lt Kamini Roy of Demdema busty, PO Salugara, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
