Sir,

in producing herewith one accused person namely Supati Mandal (48 yrs), S/O- Lt Asananda Mandal Of Maharajghat, PO: Milanpally, PS- NJP, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 12 (Twelve) Bottle of Blu 80 Up country spirit containing 600ml. each.

I ASI Dipak Singha of Milanpally out post under NJP PS do here by lodged a written complaint to the effect that today on 25.08.22 at 19:25 hrs acting on a tip-off source information myself along with C/ 997 Amal Barman, C/ 980 Sadhan Barman, VP 12 Dasarath Roy had been to Maharajghat under Milanpally OP to work out the information that a huge number of country spirit are stocked in the house of one Supati Mandal (48 yrs), S/O- Lt Asananda Mandal Of Maharajghat, PO: Milanpally, PS- NJP, Dist- Jalpaiguri without license to sale the same in the open market. This refers to Milanpally out post GDE No 674 date 25.08.22. On arrival at Maharajghat at 20.05 hrs and I called two local witnesses to witness the raid and on being identified by the engaged source we held raid in the house of Supati Mandal and could recover the above noted of liquor. During raid the above noted accused person was arrested from whose exclusive possession the above noted liquors were found. On demand he could not produce any license/documents in support of his possession. On interrogation he admitted that he has been running the business clandestinely since long. Accordingly I seized the above noted liquor proper seizure list and arrested the accused person U/S - 41 Cr.P.C and took him into the custody. The seizure was made in between 20:15 hrs to 20:45 hrs.

Hence, I pray that a specific case under proper section of law may kindly be initiated against the accused person namely Supati Mandal (45 yrs), S/O- Lt Asananda Mandal Of Maharajghat, PO Milanpally, PS- NJP, Dist- Jalpaiguri
