In producing here with the one arrested accused person namely Bijay Sarkar (35yrs) S/o- Lt. Ranjit Sarkar of Tikiapara, Matangini- I, W/no- 28, PS- Siliguri, Dist- Darjeeling along with 10 (Ten) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 ml along with all connecting papers. (Total market value RS/- 120 X 10 = Rs1200/-)

I ASI Rabin Lama s/o Birendra Kumar Lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Bijay Sarkar (35yrs) S/o- Lt. Ranjit Sarkar of Tikiapara, Matangini- I, W/no- 28, PS- Siliguri, Dist- Darjeeling, to the effect that on 27/08/2022 during Plain cloth mobile van duty (vide Siliguri PS GDE no 1667 dated 27/08/2022) at about 18.55 hrs I received a source information from Bagrakote ward no 18 under Siliguri PS, that one person namely Bijay Sarkar, is selling huge quantity of liquor illegally at Bagrakote Bus Stand ward no 18 under Siliguri PS to his design customers since long, for his wrongful gain. After sharing the information with I/C Siliguri PS and as per his kind direction, I along with ASI Siben Sarkar, ASI Debasish Das, CV/283 Prasenjit Dey, C/V 622 Ramanath Barman proceeded to the P.O to work out the source information. At about 19:15 hrs I along with my police team reached at Bagrakote Bus Stand on being identified by the source our police team held raid and managed to apprehended the said person, and recovered 10 (Ten) sealed bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (Total market value RS/- 120 X 10 = Rs1200/-) On interrogation he disclosed his identity as Bijay Sarkar (35yrs) S/o- Lt. Ranjit Sarkar of Tikiapara, Matangini- I, W/no- 28, PS- Siliguri, Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor, accordingly I seized the same viz; 10 (Ten) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 ml along with all connecting papers. (Total market value RS/- 120 X 10 = Rs1200/-) from the possession of Bijay Sarkar (35yrs) S/o- Lt. Ranjit Sarkar of Tikiapara, Matangini- I, W/no- 28, PS- Siliguri, Dist- Darjeeling, the seizure and labelled was made in between 19:25 hrs to 20: 05 hrs in presence of witnesses duly sign by the accused as well as witnesses. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested Bijay Sarkar (35yrs) S/o- Lt. Ranjit Sarkar of Tikiapara, Matangini- I, W/no- 28, PS- Siliguri, Dist- Darjeeling under proper section of law.
