Sir,

In producing herewith one accused person namely Aryan Pradhan (23) S/O- Sri Mohan Pradhan of Rabangla ,P.S- Alley Dist- South Sikkim, Sikkim along with the following seized articles:-

1. 17 (seventeen) bottles of Kingfisher Strong premium beer each bottle containing 650 ml. bolted by Brewed & Bolted by United Breweries Ltd. Vittal Mallya Road, Kalyani, West Bengal.

I, SI Sibdhan Karmakar of Pradhannagar P.S. under Siliguri Police Commissionerate do hereby by lodged a written complaint against Aryan Pradhan (23) S/O- Sri Mohan Pradhan of Rabangla ,P.S- Alley Dist- South Sikkim, Sikkim to the effect that on 27/08/2022 at 17:05 hrs. Received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his Hotel name and style as "Durga Hotel" situated at Siliguri Junction in front of Tenzing Norgey Bus Terminus in order to sale his design customers for his wrongful gain . Accordingly the fact is informed to you and as per your kind direction myself along with CV 223 Swapan Chettri and CV 645 Pankaj Gupta left for Siliguri Junction in front Tenzing Norgey Bus Terminus under Pradhannagar PS to verify the veracity of the information. This refers to Pradhannagar P.S. G.D.E. No-1735 date 27/08/2022 . On reaching there and as identified by source cordoned the Hotel where he kept illegal alcohol. On arriving there found the above noted person who disclosed his name & identity as noted above who kept the same in the said Hotel in conceal position. On searching found 17 (seventeen) bottles of Kingfisher Strong premium beer each bottle containing 650 ml. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business under the command of hotel owner namely Roshan Lama since last few months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizure list duly signed by the witnesses. The seizure was made in between 18:05 hrs to 18:35 hrs. On being asked he stated that he kept the same with a view to sale and supply Siliguri Bus Terminus area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said illegal beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accused Aryan Pradhan (23) S/O- Sri Mohan Pradhan of Rabangla ,P.S- Alley Dist- South Sikkim, Sikkim and hotel owner namely Roshan Lama as per proper section of law.
