

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 27.08.22 in course spl mobile van duty at PS area with force CV/128 Ajay Kr Sahani, CV/242 Rakesh Mongar vide PDN PS GDE NO 1735 dtd. 27.08.22, at 19.05 hrs, I received an information that the one person namely Dinesh Sahani is storing and selling liquor illegally in his Tea Shop at Regulated market under Pradhannagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search his shop recovered above noted articles, On demand apprehended person failed to produce any valid document in respect of recovered articles. On interrogation he admitted that selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 19.15 hrs to 19.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Dinesh Sahani (45) S/O Lt Rajendar Sahani of Collipara, Near Kiranchandra Sasan Ghat, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
