Sir,

In producing herewith one arrested accused person named Arjun Mandal (24 yrs) S/O Late Bharat Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling along with the following articles under proper seizure as per seizure list.

(i) 14 (Forteen) bottles of 'Himalayan Gold 60 UP' Country Spirit, each bottle containing 600 ML and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".

I, ASI Tapan Das of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the arrested accused person namely Arjun Mandal (24 yrs) S/O Late Bharat Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling to the effect that on 27.08.2022 at 16.05 hrs I received a specific source information that one Arjun Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling is selling illicit liquor at his residence without any valid license for his illegal gain. Accordingly, the fact was diarized in General Diary vide Matigara PS GDE No 1465 Dated 27.08.22 and shared the information with O/C Matigara PS and as per his kind order and direction myself along with force had been to B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling to verify the veracity of the information in hand. On reaching there and as identified by the source we held raid at the house of said Arjun Mandal and managed to apprehend him. On being asked he disclosed his identity as Arjun Mandal (24 yrs) S/O Late Bharat Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling. Further being searched the above noted seized articles were recovered from his residence. On demand he failed to produce any valid license/papers for selling and storing of such articles. During enquiry it is learnt that the said Arjun Mandal (24 yrs) S/O Late Bharat Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling is involved in selling and possessing of liquor without any valid license for last few months for her illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned accused person named Arjun Mandal (24 yrs) S/O Late Bharat Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 27.08.22 in between 16.45 hrs to 17.35 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused namely Arjun Mandal (24 yrs) S/O Late Bharat Mandal of B.T. Ranadip Colony, PS- Matigara, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
