This is to inform you that I Subhamay Mitra,  
C/O - Sujay Kumar Mitra, R/O - Vidya Sagar Pall  
Ranidanga, Ranidanga, Dist - Darjeeling, West Ben  
734012, that today on 27/08/2022 around 10.30 am or war  
in the ~~morning~~ morning. my father namely Sujay Kumar  
Mitra went to bazar for grocery shopping while going  
near Ranidanga Petrol Pump of Indian oil namely M/S -  
Swastik Fuel at Ranidanga Vidyasagar Pally. a speeding  
Tata Magic, (red) in colour, having vehicle registration no  
WB 76A 7541, hit my father on the road. Due to the  
collision my father above named Sujay Kumar Mitra  
succumbed head and chest injury, whereas the accursed  
vehicle driver fled the scene then around 10.40 am at  
the morning immediately after the accident my father was  
rushed to North Bengal Medical College (Emergency ward  
where he was declared Brought Dead on arrival. So I  
humbly request you to take necessary and immediate  
action against the said accursed person i.e the  
driver of the said vehicle as mentioned above.
