SIR, I, Jayshree Sutradhar (aged 69 years) w/o DR. M. Sutradhar (aged 75 yrs) would like to bring to your kind and immediate attention that I had purchased 15 Kathas of land (Khatian Nos. 232 and 336) MOUZA: DABGRAM, sheet no: 50, at ERTIYASHAL, BHAKTINAGAR, DISTRICT JALPAIGURI on 16-07-1990 and it is in my possession since then.

- now, SRS SUSHANT ROY, s/o LATE BIJOLANATH ROY, NORTH-ERTIYASHAL, P.O. SEVOKE ROAD, P.S. BHAKTINAGAR, DIST. JALPAIGURI, has suddenly started claiming the ownership of this land after almost 32 years.

- I had built 8 feet tall brick wall along the boundary and also a small store house with iron shutter about 20 years ago.

- I was informed recently that a part of the boundary wall had collapsed then the above named person (Shri. SUSHANT ROY) came and built a bamboo fence forcibly along the collapsed wall. We tried to repair the wall after he removed the bamboo fence but he is preventing us to repair the wall. In fact he along with a few of his associates has destroyed some parts of the wall as well as a part of the store house.

- he has been threatening and harassing us, taking advantage of our old age and our absence there. He is applying all sorts of tricks to grab my land.

- So, I request you to kindly take necessary action for our safety and peaceful possession of our land. Thanking You,
