Respected Madam,

I, Smt. Phoolkumari Choudhary, W/O Sri Sushil Yadav, Daughter of Lt. Jay Narayan Choudhary, now resident of C/O Lt. Jay Narayan Choudhary, Ho chi Min Nagar, Upper Bagdogra, P.S. Bagdogra, Dist Darjeeling, do hereby lodge this FIR to the effect that on 12/2/2018, I was married (As per Hindu Rites) to Sri Sushil Yadav, Permanent Resident of C/O Baijnath yadav, Nutanpally, Ward no.8, N.N. Road, Coochbehar. During my marriage my family gave dowry consisting of gold ornaments worth 10 lakhs, T.V., Refrigerator, almirah, sofa, utensils, bed, and many other household items and costly clothes as per demands made by my husband and in laws. After marriage, I started living with my husband and in laws in their home at Nutanpally, Ward no.8, N.N. Road, Coochbehar.

After about two years of marriage my husband, started to neglect me and torture me mentally and whenever he came home for week ends, he would quarrel with me on trivial things and complain that he had been cheated as I was not the girl that he wanted, even if he made mistakes, he would accuse me of doing it and my father in law, mother in law, brother in law and his wife, would support him and say that I must have some fault and that's why he was unhappy. My in laws used to instigate my husband and tell him to do as he pleases with me. All my gold and other stridhan properties were kept in my in laws' custody from the very beginning and I never objected since I wanted to make all compromises to keep my husband and his family happy.

In spite of all mental torture that was committed on me, I and my family kept silent and did not make any complaints anywhere with the hope that I one day my husband and in laws will realize their mistake and accept me. However that never happened and by the end of December 2020 my husband started to assault me physically and told me several times to leave his house and go to my parental home and leave him alone so that he could do as he pleases. He could not tolerate me or my family members and always had lots of complaints against me and insulted me in front of outsiders and his family also supported him and instigated him to commit such offences against me.

My husband never gave me the status of a wife and he never went with me anywhere and never came with me to my parents' home and so when my father was admitted in ICU and later died I had come alone to my parental home on 14/02 2021 to do my duty as his daughter but neither my husband nor my in laws even came to give condolence to my widowed mother and other family members. Later when I wanted to go back to my matrimonial home my husband told me not to come back and he even renounced the marriage and told me that he did not want to live with me although he knew that I wanted desperately to continue with the marriage.

When my family members wanted to mediate and tried to talk to his parents they refused to interfere and told them that I was at fault but I never came to know what my fault was.

When I told them that I had a right to stay at my matrimonial home and be maintained by my husband, my brother in law threatened that he would make my whole family suffer if I ever claimed any right whatsoever from his brother.

Sir, after four years of marriage I now have no place to go and I am a helpless destitute because of my husband's whimsical and neglectful behavior.

After this incident I was not allowed to enter my matrimonial house and I was ultimately given shelter by my family and as such I am residing at my family house, under their custody and with financial help from my family and relatives since 14/02/2021

Sir, although my family members have tried to mediate and come to peaceful settlement with them they have not succeeded. My husband earns around Rs.50,000.00 from his job as geography teacher of B.S.F School, Kadamtala, and other sources but he has not paid anything for me till now and has refused to accept any of his liabilities and has also renounced our marriage and I fear that he is also planning to remarry.

Sir, the aforesaid activities of my husband Sri Sushil Yadav, my father in law Sri Baijnath Yadav, mother in law Smt. Gayatri Yadav, Brother in law Sri Ram Yadav have gone beyond my tolerance. I am now in a helpless condition and I need your help urgently to start appropriate legal action against the aforesaid persons, all residents of Nautanpally, ward no .8 N.N Road . Coochbehar.

It may be mentioned here that I could not lodge the FIR earlier because I was in a state of shock and my relative were trying to mediate with my husband and inlaws as mentioned above.
