Respected Sir,

I, Sandhya Sharma, Wife of Arjun Sharma, resident of Parkash Nagar, Shani Basti, Ward No. 43 of S.M.C. P.O. Salugar, P.S. Bhakti Nagar, Dist- Jalpaiguri, would like to report you the following facts:-

1. That on 02.02.2018 my marriage was solemnized with Arjun Sharma, and out of our said wedlock relation we have one son name Master Dhrup Sharma, as because our marriage was love marriage so as per the expectation of my in-laws I can not bring any thing from parent's house.
2. That after some weeks of my marriage my husband along with his family members i.e. father in-law Rohit Sharma, mother in-law Krishna Devi Sharma, and my dewar Ankit Sharma started taunting me continuously, which I tolerated in the hope that one day they will change their nature and character but their torture upon me did not stop and knowing the aforesaid fact my parents gave Cash Rs.4,00,000/- and one pair of Gold ear rings, nose pin, neck chain made of gold and two finger rings made of gold, expensive clothes to my husband and requested my husband not to torture me.
3. That even after that their torture upon me did not stop rather they started demanding more money from my parents otherwise they would divorce me and marry my husband somewhere else. Several times in order to get rid of me they planned and tried to kill me. My mother-in-law kept the gas cylinder open so that I may get burn while cooking. They never gave me three times food and always made to have stale and left over food that also for one time or two times a day.

Thereafter, they started spreading rumors about me that I have some venerable disease and is not suitable for my husband and few months earlier they forcefully caused my miscarriage by giving me some medicines otherwise they would kill me and my minor son.

4. That on 05.08.2022 my husband and aforesaid in-laws after assaulting me drove me out from my in-laws house and even snatched my minor son from me and told me bring cash Rs.10,00,000/- then only they will allow me to enter my in-laws house and allow me to see my son.
5. That thereafter, finding no other alternative I came to my father's house and since then they have neither gave my son to me nor took care of him. I came to know that my son was suffering from fever and they did not take care of him nor provide medicines and when I and my family members requested them allow me to see my son then they told that until and unless I do not bring Rs.10,00,000/- from my father's house they would not allow me to see my son and hide him in such a place that I cannot find him for the whole life.
6. That on 28.08.2022 I came to know that my said son is not feeling well then my father anyhow managed Rs.50,000/- and gave to me so that I can give to my in-laws and they would allow me to see my son and then I taking Rs.50,000/- went to my in-laws house at that time they took Rs.50,000/- from me but did not allow me to see my son and then I protested at that time they became furious and started assaulting me and my mother-in-law hit me on my head by a Belan and nose and my brother-in-law hit me hard on my stomach as a result of which I fell down on the ground then my husband and his father started to strangulate me with an intention to kill me and my mother-in-law brought a rope so that they can hang me by it but anyhow I freed myself from the hands of my husband and raised hue and cry and out of fear of para people accumulating they left me and I fled away from there.

7. That due to their such assault I received severe bleeding injuries on my person and my parents took me to Siliguri S.D. Hospital and I was admitted there for my critical condition.

8. That Sir, my son is only 3 ½ years old if he remains in their custody no one is going to look after him. His life will be ruined if he remains with them. I request you to kindly recover my minor son from their custody.

9. That I got discharged today hence, delay is caused in lodging this F.I.R.

I, therefore, requested you to kindly take necessary legal action in the aforesaid matter against the aforesaid culprits.


