S.M.C, Siliguri, District: Jalpaiguri beg to
state as follows:

① That one Md. Taslim, Md. Jalal and
his wife Yasmin of Near Mount View School,
Ashraf Nagar, Ward No. 40 S.M.C. were
staying as tenants at my residential plot
at Ashraf Nagar which is registered on
my mother's name Akatari Begam.

② That the above named three people
were staying at my residential land
and were plotting against my said
mother.

- ③ The said Md. Jalal and his wife Yasminie got duplicate keys made of one of the residential house and helped Md. Taslim help get his stuffs from the residential house and helped him escape without paying rental fee of five months amounting to Rs. 15,000/-.
- ④ That today i.e. 01.09.2022 at around 4:00pm my said mother Akbari Begam went to check her rental houses as usual, where she found out that one of the houses where Md. Taslim was staying was opened and things were missing.
- ⑤ That on finding that Md. Jalal and his wife Yasminie had helped him to get the duplicate keys and escape out from the house without paying rent, my mother asked the said Yasminie as to why did she do so, then the said Yasminie started to abuse my mother with filthy languages and started

calling her with bad names. When she asked her not to do so, she said Yasmine pushed my mother against the wall hard where my mother sustained injuries on her head. My mother who is a heart patient and has continuous ~~low~~ high bp could not take the hard push on her chest and collapsed there. While she was unconscious she said Yasmine and her husband had ~~taken~~ ^{gala} snatched away the gold chain which she was wearing in her neck.

⑥ That when my mother gained some conscious one Leekara Khaloon who is the neighbour of Yasmine came with furious nature and started hitting my mother continuously on her chest and threatened to kill her saying that "Heart ka Marij hai na, Yahi Naar dege tumhe".

⑦ That the said Rukhsara Khatoon, Md Jalal and Yasmin (his wife) continuously threatened my mother of killing her in case she does not go away from there.

⑧ The said Rukhsara Khatoon also tore off my mother's kurtā and removed her dupatta saying if she does not go away she will make her suicide in front of everyone. The said Md. Jalal also supported her in this and threatened my mother.

Sir, my mother is an old lady with serious health issues and the above named persons are very dangerous in nature and I request you to kindly take serious action against the above culprit.
