With due respect, I am producing herewith the following articles under seizure.

- I. 13 (Thirteen) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ML.
- II. 06 (Six) bottles of Tuborg Strong Premium Beer each bottle containing 650 ML.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 02.09.2022 at 00.05 hrs I received a secret source information that one person namely Krishna Sribastab (35) S/O Anil Kr. Sribastab of Bhagabanpur Chak, P.S- Mujaffarpur, Dist.- Mujaffarpur (Bihar) is selling ID liquor illegally at Ratan Hotel at NJP Hotel Line area under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 47 dated 02.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Hotel Line area under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 00.35 hrs we arrived NJP Hotel Line area, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling Illegal Distilled liquor to regular customers at Ratan Hotel situated at NJP Hotel Line area and hold raid at his hotel. but seeing the police party he along with customers were able to fled away. On search the above noted I/D liquor recovered from Ratan Hotel. Accordingly, I seized the above noted I/D liquor from the Hotel under proper seizure list. The whole process of search & seizure was made in between 00.55 hrs to 01.15 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused namely Krishna Sribastab (35) S/O Anil Kr. Sribastab of Bhagabanpur Chak, P.S- Mujaffarpur, Dist.- Mujaffarpur (Bihar) and arrange for its investigation.
