Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 134 dated 03.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Hotel Line area under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 18.55 hrs we arrived IOC Gate area, PS- NJP, Dist.- Jalpaiguri and being identified by the source found the said accused person selling Illegal Distalled liquior to his regular customer at his shop situated at IOC Gate area and as per the indication of source managed to apprehended him.
