With due respect, I am producing herewith one arrested accused person namely Bivas Dutta (35) s/o Subhash Dutta of Bhutta Bari, S.S. Colony, E Block, P.S- NJP, Dist.-Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him the following articles under seizure.

- I. 08 (Eight) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ML.
- II. 05 (Five) bottles of Kingfisher Strong Beer each bottle containing 650 ML.
- III. 02 (two) bottles of McDowells No. 1 celebration Rum each containing 180 ml.

I, PSI Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 03.09.2022 at 20.55 hrs I received a secret source information that one person namely Bivas Dutta (35) s/o Subhash Dutta of Bhutta Bari, S.S. Colony, E Block, P.S- NJP, Dist.-Jalpaiguri is selling ID liquor illegally at his shop at NJP Railway Hospital More area under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 138 dated 03.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, SPC left for NJP Railway Hospital More area under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 21.15 hrs we arrived NJP Railway Hospital More area, PS- NJP, Dist.- Jalpaiguri and being identified by the source found the said accused person selling Illegal Distilled liquor to his regular customer at his shop situated at NJP Railway Hospital more area and as per the indication of source managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his shop at NJP Railway Hospital More area under NJP P.S since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the bag carrying by him Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 21.25 hrs to 21.55 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Bivas Dutta (35) s/o Subhash Dutta of Bhutta Bari, S.S. Colony, E Block, P.S- NJP, Dist.-Jalpaiguri and arrange for its investigation.
