Dear sir,

I, Roshan Paswan S/o Rajkumar Paswan resident of Rana Basti, Subhashi Pally, Bagra Court, Siliguri - 734001, would like to bring to your attention the following matter:

1. That a person named Tanu Roy S/o Cheta Roy resident of adhikar pally, goramore, pin - 735135, along forcefully entered my Working Place (Hot Wheels Logistics India Private Limited) at adhikar pally, goramore more, on Thursday (01-09-2022) at around 10:20 pm.
2. For matters unknown he demanded a sum of money saying 'you had to pay us to work and live in this city'.
3. Upon my refusal and politely asking him to leave my Working Place he started abusing me and told me that he would kill me if I step out from here.
4. That he also told me if I don't pay the particular sum of money he would kill me anytime on the street.
5. That I implore you to look into the matter and provide me protection against such unsocial elements I deeply think my life is threatened by him.

I request for swift and immediate action to catch the culprit.
