Sir,

With due respect and in producing herewith one arrested accused person namely Nakul Barman (30) S/O Hem Barman of Kalabagan, Patiramjote, PS-Matigara, Dist- Darjeeling with following seized articles :-

- One Bolero Pickup vehicle bearing Reg. No. WB-73-F- 0586 loaded with River bed materials.
- One key of the said vehicle.

In this regard, I PSI Agen Lepcha of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 07/09/2022 at about 07:00 hrs onwards I received a source Information that one vehicle bearing Reg. No. WB-73-F- Nakul Barman (30) S/O Hem Barman of Kalabagan, Patiramjote, PS-Matigara, Dist- Darjeeling 0586 loaded with River bed materials coming from Patiramjote Kalabagan side without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction I along with force had been to Patiramjote Kalabagan under PS Matigara to work out the information in hand. After arrival at the spot I found said vehicle bearing Reg. No. WB-73-F-0586 loaded with River bed materials was coming from, Patiramjote Kalabagan under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. On further interrogation, he stated that he mines such river bed materials from Parimalnagar Ghat under Matigara PS by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle loaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Nakul Barman (30) S/O Hem Barman of Kalabagan, Patiramjote, PS-Matigara, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.
