Sir,

In producing herewith three arrested accused persons namely (1) Monoj Kumar Sahani-55yrs s/o Lt Sonelal Sahani of Sahani Busty, Prakashnagar, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Raju Sahani-32yrs s/o Ram Chandra Sahani of Sahani Busty, Prakashnagar, ward no-43, PS Bhaktinagar Dist Jalpaiguri and (3) Naren Roy-24yrs s/o Dalim Roy of Dadabhai colony PS Bhaktinagar Dist Jalpaiguri along with seized articles viz:- Three loaded Trucks bearing plate no-(1) WB78/2769 (2) WB73B/8505 & (3) WB73/1217 loaded with River Bed materials/Sands.

I ASI Nitai Mandal of Bhaktinagar Police station under Siliguri Police Commissionerate lodge a written complaint against the above noted persons to the effect that today i.e. 08.09.22 at 04.05 hrs during my PS mobile duty had been to Prakashnagar Militari Ghat and found three loaded Trucks bearing plate no-(1) WB78/2769 (2) WB73B/8505 & (3) WB73/1217 loaded with sands was started from Militari Ghat at Prakashnagar under Bhaktinagar PS. On checking myself along with PSI Chiranjit Saha, C/986 Rajib Sarkar, C/1431 Dilip Barman, CVF/935 Bipllab Roy, CVF/619 Dharmendra Roy, all of Bhaktinagar PS apprehended that vehicles along with its driver and on further checking the vehicle and found the truck loaded with sand. On demand, the driver of the Truck disclosed his name and identity as noted above. Further, on demand the driver of the truck failed to produce any valid documents related to the Truck as well as the loaded River Bed materials/sand in the Trucks. Hence there was reason to believe that the driver of the Trucks have procured the loaded sands illegally and transporting the same for their illegal gain from Mahananda River.

On further grilling they discloses that they have procured the river bed materials, sand illegally from Prakashnagar Military Ghat and carrying/transporting the same to Siliguri side from river bed for their wrongful gain without any valid documents. Under the circumstances, I seized the Trucks bearing Registration No. -(1) WB78/2769 (2) WB73B/8505 & (3) WB73/1217 along with loaded sands under proper seizure list and arrested the drivers of the Truck under proper Memo of Arrest after explaining the reason of arrest to them in presence of local witnesses. The whole process of search, seizure took place in between 04.45hrs to 05.20 hrs.

Under the above, I pray before your kind end to start a case against the above arrested persons namely (1) Monoj Kumar Sahani-55yrs s/o Lt Sonelal Sahani of Sahani Busty, Prakashnagar, ward no-43, PS Bhaktinagar Dist Jalpaiguri (2) Raju Sahani-32yrs s/o Ram Chandra Sahani of Sahani Busty, Prakashnagar, ward no-43, PS Bhaktinagar Dist Jalpaiguri and (3) Naren Roy-24yrs s/o Dalim Roy of Dadabhai colony PS Bhaktinagar Dist Jalpaiguri and its owners under proper section of law and caused its investigation.
