I, Ashraf Ansari (30) s/o Md. Giliyas, presently residing at Beldangi (Near Madrashe) Tumbajote, P.S. Mukiyara, Distt-Dejceery, beg to inform you that on dt 01-09-22 at about 11:10 hrs, when my father namely, Md. Giliyas (62) reached at 2 No. Tyoti Nigaz Colony (Near Tyoti Nigaz Post office) at that time, a motor cycle (Royal Enfield) bearing Regd. No. WB-74-AT-2757, came in a rash & negligent way and badly dashed to my said father, as a result he fell on the ground & received severe injury and admitted at Shanti Nursing Home, Sevoke Road, Siliguri.

Later on we came to know that the said Motor Cycle was driven by one Depayan Singh Roy (19) s/o Debdas Singh Roy of 2/4 No. Road, Pati Colony PO & P.S. Pradhan Nigaz, Distt-Dejceery at the time of accident.


