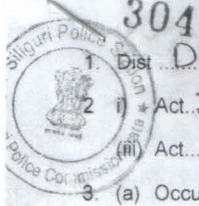

SUBJECT- FIR

Respected Sir,

I, Sri. Birendra Sahani, S/o of Late Akalu Sahani resident of Maharaj Colony near Bholebaba Mandir, P.O & P.S – Siliguri, Dist – Darjeeling would like to inform you that on 30/08/2022 at about 1 p.m in the afternoon 3-4 men attacked me at Maharaj Colony, near Bholebaba Mandir, P.O & P.S – Siliguri, Dist – Darjeeling, when I was going for my work. Among them I could recognize only 2 of them namely 1. Sri. Jitendra Singh @ Jitey S/o Pintu Singh 2. Sri Krishan Mandal S/o Ramesh Mandal both are residents of near Kachra Math, Hemanta Basu colony, Ward No. 4, P.O & P.S – Siliguri, Dist – Darjeeling suddenly stopped me and without saying a word started hitting me with a 2 or 3 strong and thick bamboos on my head and my rest of my body. Then they pushed me very hard due to which I fell down on the road from my bike and then they started kicking me on chest and abusing me with filthy word. Two men held my hand from back and aboved- mentioned Sri. Jitendra Singh @ Jitey & Sri Krishan Mandal snatched my purse and stole about Rs. 6000/-. After that the said Sri. Jitendra Singh @ Jitey & Sri Krishan Mandal took out two sharp knives and tried to stab me and while I was trying to save myself and I was brutally injured. My hand was deeply cut and I started bleeding profusely. There are various cuts and bruises on various parts of my body. Seeing me in that condition few people started to gather and seeing the crowd they ran away threatening me that they would attack me again and kill me.

Immediately few people seeing me in such a condition took me to the Siliguri Hospital for treatment and after which I came back home and was in complete bed rest hence could not file a written complain. I am living my life in extreme fear and agony. I will be obliged if you kindly look into the matter and do the needful for ends of justice and consider my application as FIR. Kindly take necessary legal actions as per the provisions of law.
