With due respect I, SMT. JYOTSNA GHOSH, Wife of Late Gouranga Chandra Ghosh, Resident of Yadav Pally, Ward No. 07 of S.M.C., Siliguri, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling and presently residing at C/O - B.K. Roy, Ashram Para, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that I am aged about 70 years and being the Senior Citizen, suffering with severe old aged ailments. Sir, I am the absolute and exclusive owner of all that piece or parcel of land measuring 03 Kathas, together with a three storied building, appertaining to and forming part of R.S. Plot No. 2384, recorded in Khatian No. 4183, Mouza - Siliguri, J.L. No. 110(88), within Ward No. 07 of Siliguri Municipal Corporation, under the jurisdiction of Police Station - Siliguri, Dist. Darjeeling, being Identified as Holding No. 278/9/A/247 of Ward No. 07 of Siliguri Municipal Corporation and I have acquired the said property by virtue a Deed of Gift, executed by my father being Document No. 1 - 5364 for the year of 1999. Sir, Gouranga Chandra Ghosh (Since Deceased) was my legally married husband and we have three sons namely (1) Goutam Ghosh, (2) Sanjib Ghosh & (3) Sajal Ghosh and three daughters namely (1) Smt. Anita Ghosh, (2) Smt. Nandita Ghosh & (3) Smt. Mithu Ghosh and all are married and my married daughters have been residing at their respective matrimonial house and my three sons with their wives have been living in my own property. Sir, my elder son namely Goutam Ghosh was married with one Smt. Apu Ghosh and since after their marriage, my elder son in conspiracy with his wife have started to inflict torture upon me and my husband (since deceased) both mental and physical and they have also misbehaved with us and did not hesitate to throw filthy and abusive languages toward us and due to their said inhuman torture, my husband expired in the year of 2015. Sir, after the demise of my husband, they became more arrogant and started to inflict more torture upon me with a view to oust me from my own house and capture my entire property in their custody and thereby, they have started to create disturbance in the daily household activities of my house. My elder son and his wife in conspiracy with each other have restrained me forcefully to use the common water-tap and sometimes, they used to throw garbage and dirty water in front of my room and as and when, I made protest against their said illegal acts and activities, they abused me with filthy and abusive languages and also threatened me with dire consequences to oust me from my own house forcefully. They have also restrained me to use the terrace of our house and threatened me that they will not allow me to stay in my house and

Sir, it is very pertinent to mention here that my elder son is a person of bad character and he has been engaging himself in the different illegal activities for his wrongful and illegal gain and when I made protest against his said illegal activities, he did not hesitate to assault me and threatened me by saying that if I did not agree with his said demand and if I will not transfer my entire property in his favour, he will not hesitate to kill me and subsequently, on 05.05.2022, my elder son and his wife have forcefully ousted me from my own house and threatened me to ruin my life permanently if I again try to enter into my house and finding no other alternative, I left my own house and took shelter in a rented house at C/O - B.K. Roy, Ashram Para, P.O. & P.S. Siliguri, Dist. Darjeeling. Sir, I am an widow lady aged about more than 70 years, and due to the constant physical and mental torture of my elder son and his wife, I have been suffering with extreme mental anxiety and passing my days with extreme fear in a rented house and I apprehends that my elder son and his wife may attack upon me at any moment in order to fulfill their wrongful and illegal gain and they regularly pray when I will die and thereby, they capture my entire property.

I, therefore, being a Senior Citizen, fervently requesting you to look into the matter properly and please take necessary legal steps against my elder son namely Sri Goutam Ghosh and his wife Smt. Apu Ghosh for causing mental and physical torture upon me and also for causing physical assault upon me so that, I can live my remaining life happily and peacefully at my own house and obliged thereby.
