Sir,

With due respect and with reference to the subject cited above, I, the undersigned Shri Vishwajeet Chatterji, son of Shri Ranjit Kumar Chatterji would humbly beg to crave few lines for favour of your kind information and necessary action.

Sir, I would like to highlight that on 4th September, 2022 at around 10.45 am one person Shri Anindya Bagchi who is my neighbor intentionally damaged my two wheeler motor cycle bearing registration No. WB 74 AY 3912 by his four wheeler Wagon R bearing registration No. WB 74 M 7148 there by damaging by vehicle to a great extent. Not only this he even quarreled with me and threatened me and my wife with our lives and with dire consequences.

It is also pertinent to mention that his accomplice Shri Sibubowel, resident of P.C. Sarkar Sarani, Hakimpara, Siliguri, Pin Code - 734001, Darjeeling Dist. , W.B also attempted to kill me through his Truck bearing No. WB 19 G 2021 on 29th August, 2022 but fortunately I escaped and since then almost every day Shri Anindya Bagchi is trying to harm me in one way or the other.

Sir , I strongly anticipate and apprehend that if the accused Shri Anindya Bagchi is not put behind the bars immediately then I will have to loose my life as he or his accomplice will surely kill me for no reason or rhyme.

Henceforth, I in deep profound, grief and sorrow and forced by the circumstances requests and pray before your good self to kindly arrest the accused Shri Anindya Bagchi immediately as he is threatening me day in and day out. I shall remain highly obliged to you good self.
