Respected Sir,

With due respect, I Sri. Chandra Bahadur Chhetri, S/o. Sri. Durga Prasad Chhetri, residing at Kalabari, Champasari Road, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling being the constituted attorney of SRI. RAJ CHETTRI, Son of Sri. Kumar Chhetri, residing at Haren Mukherjee Road, Hakimpara, P.O. & P.S. Siliguri, Dist. Darjeeling beg to state that said Raj Chettri is absolute owner of a piece of land measuring about 4.13 Decimals, recorded in L.R Khatian no. 3005(Old), 3687(New), under R.S. Plot No. 98, 98/1 & 96, corresponding to L.R. Plot nos. 284(0.0213 Acre) & 291(0.02 Acre), situated within Mouza Palash, J.L No.43, P.S. Pradhannagar, Dist. Darjeeling by virtue of a registered deed of conveyance being no.I-2933 for the year of 2021 which was sold by Bina Chhetri @ Bina Gautam.

On several occasions including on 25/07/2022 and on 01/08/2022, one SRI. GUDDU ROY, Son of Sri. Pramod Roy, resident Uttar Palash, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling and his men and persons have obstructed us and demanded money and they have forcibly tried to capture the above mentioned land. Finding no other alternative, said Raj Chettri represented by me has filed a civil suit vide T.S. No. 230/2022 against Guddu Roy and on 03.08.2022 and after hearing Ld. Court was pleased to pass an order as follows:-

..... " the defendant is hereby restrained from entering into the suit property or disturbing peaceful possession of the plaintiff thereon till 15.09.2022."

Inspite of order of the Ld. Court, the above named Guddu Roy and his mother Pampa Roy@Baasi and Others have been continuously disturbing us and they are disregarding the order of Court and today on 03/09/2022, when I went to the above mentioned land on behalf of Raj Chettri to clean the land, the above named Guddu Roy and Pampa Roy@Baasi have threatened me and tried to capture the land forcibly. They are demanding huge amount from us for the purpose to extort us unlawfully.

Therefore, I request you to take necessary legal action against said (1) SRI. GUDDU ROY, Son of Sri. Pramod Roy, (2) Pampa Roy@Baasi, W/o. Sri. Pramod Roy, both are resident Uttar Palash, P.O. Champasari, P.S. Pradhannagar, Dist. Darjeeling and also to see that the order of Ld. Court may not be violated by them.
