

With due respect I, **SMT. BABY SARKAR**, W/O Sri Dilip Sarkar, presently residing at Chaitanyapur, Near Paper Mill, Shivmandir, P.O. & P.S. Matigara, Dist. Darjeeling, would like to lodge this written complaint to the effect that I am a old aged Senior Citizen (Aged about 62 years), have been residing with my husband Sri Dilip Sarkar, (Aged about 72 years) and we have one son namely **SUBHA SARKAR** who is married with one **SMT. KAJAL SARKAR (BISWAS)** and one daughter namely **RIYA CHANDA (SARKAR)** who is also married and after her marriage, she is residing at her matrimonial house with her husband Sri Santanu Chanda happily and peacefully. Sir, previously I along with my husband have purchased a house property and started to reside at Shivmandir, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling for the safety and security of my only son who was involved and started to mix up with so many anti-social persons of the locality and also becoming a habitual drunker.

After shifting there, I have purchased a shop room near Medical College & Hospital for my only son and I have also provided with all the required materials/goods for his business purpose with a hope that my son will rectify himself by doing the said business and will remain busy in his business works. I have also provided financial assistance to him so many times for purchasing goods for his business but after finishing of his capital, he again and again started to place monetary demand for his business. Not only that, on my refusal to provide further amount to him, he started to cause mental torture upon me and my old aged husband who is suffering with severe old aged ailments.

Sir, since last few years my said son has become a habitual drunker and remains in drunken condition almost whole day and seeing of his such a condition, on several occasions, I taken him before Dr. Nirmal Kumar Bera, a Psychiatrist but my son refused to consume the prescribed medicines.

Sir, in the meantime, on 14.05.2019, my said son, without taking any consent and permission from us, married a lady namely **SMT. KAJAL BISWAS** and after his marriage, my son has started to take alcohol in our house premises in presence of his wife and his wife also assisted him to do the same and seeing the said situation, when I raised my objection against his said acts of consuming alcohol at home, he assaulted me mercilessly in my own home in presence of my husband.

Sir, I have been maintaining my son, his wife and my husband also through my income but my son and his wife Smt. Kajal Biswas used to take all my earnings forcefully and used to misuse the same as per their own desire and on my protest, they started to cause mental torture upon me and my son along with his wife also have been creating tremendous torture upon me with a view to squeeze money from me.

It is to be mentioned here that in the month of December, 2019, my daughter-in-law Smt. Kajal Biswas left the house leaving her husband and

thereby, she withdrawn herself from the society of her husband willingly and voluntarily and immediately, after leaving the house, my daughter-in-law has lodged a false compliant against my son before the Officer-In-Charge of Siliguri Women P.S. After leaving the house, my daughter-in-law in conspiracy with her family members have started to create tremendous pressure upon me to transfer my property in her name and to that effect, she started to threaten me and my other family members with dire consequences and due to the torture and threatening of my daughter-in-law, my son attempted to commit suicide but somehow, we recovered our son. Considering the mental condition of my son, we admitted our son in a Rehabilitation Centre namely Prayas Communication at Shastri Nagar, Ward No. 41 of SMC, Siliguri Bhaktinagar, Dist. Jalpaiguri and after receiving the said information, my daughter-in-law again started threatening me and others by sending messages through phone and also by sending some unknown miscreants and also started to make illegal demand to transfer my property and threaten us that if I failed to transfer my property in her name, in that case, she will lodge false complaint and roped myself along with my other family members including my married daughter and her husband also. Thereafter, finding no other alternative, I have lodged several complaints against my said son and daughter-in-law narrating the aforesaid acts and activities but they did not change their earlier acts and attitude and continued their inhuman torture upon us.

Due to the continuous threatening, I have compelled to sell out my said property in the year of 2021 and purchased another property at Chaitanyapur, Near Paper Mill, Shivmandir, Matigara and started to reside thereon with a view to live our remaining life peacefully but gone in vain.

Sir, yesterday i.e. on 04.09.2022, my said son again started to create tremendous pressure upon me to provide money for his own requirement and when I denied to pay any amount to him, he started to assault me physically and also pressed my throat forcefully with an intention to kill me and when my husband tried to rescue me from his hand, he did not bother to assault my husband mercilessly and threatened us by saying that if we did not pay money as per his demand or transfer our present property in his favour, he will not hesitate to murder us and thereby, capture our entire property forcefully. Sir, it is very required to mention here that presently, my daughter-in-law provoked my son to commit such type of torture upon us so that we compel to leave our own property and she has also started to threaten us by sending messages through whatsapp with a demand to transfer our property in their favour. Sir, due to their continuous torture, assault and threatening, I along with my old aged husband have been passing our days with extreme fear and anxiety and we apprehend that at any point of time, they in conspiracy with each other murder me and my husband evading the eye of law and capture our entire property for their wrongful and illegal gain.

I, therefore, fervently request your good self to investigate into the matter and please take appropriate legal steps against my son **SUBHA SARKAR** and his wife **SMT. KAJAL SARKAR (BISWAS)** as per the provision of law and oblige thereby.
