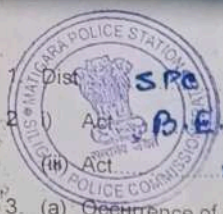

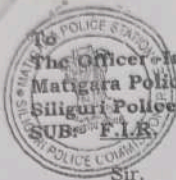

Sir,  
In producing herewith one arrested accused person named Khitish @ Bablu Barman (45 yrs) S/O Late Khetu Barman of Guriajote, PO- Nemai, PS- Matigara, Dist- Darjeeling along with following articles under proper seizure list :-

(i) 12 (Twelve) bottles of 'Himalayan Gold 60 UP' Country Spirit containing 600 ML in each bottle and value of Rs 120/- of each bottle and marked as "Exhibit- "A" out of which 01 (One) bottle taken as sample for examination and marked as "Exhibit A-1".


I, ASI Dharendra Nath Mandal of Matigara Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person namely Khitish @ Bablu Barman (45 yrs) S/O Late Khetu Barman of Guriajote, PO- Nemai, PS- Matigara, Dist- Darjeeling to the effect that on 10.09.2022 at 17.45 hrs myself along with force left the PS for holding raid against illicit liquor, Gambling etc vide Matigara PS GDE No 583 dated 10.09.22. During my duty I received reliable source information that one person named Khitish @ Bablu Barman of Guriajote, PO- Nemai, PS- Matigara, Dist- Darjeeling is selling illicit liquor at his Hotel situated at Pakhridanga, Bhuban Jote under PS - Matigara, Dist.- Darjeeling without any valid license. Accordingly, I informed the information to O/C Matigara PS and as per his kind order and direction myself along with force had been to Pakhridanga, Bhuban Jote under PS - Matigara, Dist.- Darjeeling and being identified by the source we held raid at in a hotel and managed to apprehended one person. On being asked he disclosed his identity as noted above and also disclosed that he is the owner of the said hotel. On being asked he also disclosed that he is selling illicit liquor in his hotel without any license for his wrongful gain. Further being searched the above noted seized articles were recovered from the hotel of the said accused. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of illicit liquor without any valid license for last few months for his illegal gain. Then, I seized and labeled the above mentioned liquor under proper seizure list and arrested the above mentioned detained person named Khitish @ Bablu Barman (45 yrs) S/O Late Khetu Barman of Guriajote, PO- Nemai, PS- Matigara, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 10.09.22 in between 21.35 hrs to 22.15 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against arrested accused namely Khitish @ Bablu Barman (45 yrs) S/O Late Khetu Barman of Guriajote, PO- Nemai, PS- Matigara, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


