I, Gaurav Banik, resident of ward no. 17, is writing this letter to inform you about an unfortunate attack I fell prey to at the night of 09/09/22 (Friday).

Sir, I would like to inform you that I am a member of the Nilmoni Memorial Club, opposite Shubhash Pally Post Office (ward no. - 18). I was attacked ^{near} inside the club by Rishi Shah and 3 of his friends. All the accused members are residents of ward no. 18 and they have been drinking alcohol regularly and consuming other substances inside the club's building without partaking in any useful club ~~activity~~ activity. On 09/09/22 I charged them verbally with utmost decency and held them answerable for their notorious and harmful behaviour. Due to this, they attacked me physically with their helmets, hands and other objects. I have been heavily injured, mostly caused due to blood loss and teeth and other internal injuries. Sir, I would like to lodge an FIR for the same against these harmful alcoholics and attackers. Please bring justice to my situation.
