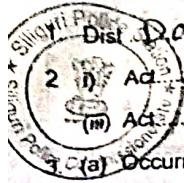

With due respect I Shri Prabir Sarkar, S/o - Late Shri
Kshitish Ch. Sarkar of Address, Matigara Gort Colony, PS - Matigara,
Dt - Doojaling, beg to state that today at around 11:30 am,
at Seroke More, on the Hill Cart Road, my son Shri Saikat
Sarkar, Age - 31 yrs, met with tragic accident.

The car no WB 54 N 0715 dashed a car bearing no,
WB 73 G 1492 which in turn dashed my son's bike bearing
Regn No WB 74 A X 4704 resulting in fatal accident.
As the result, my son's bike dashed a car bearing no
WB 74 BK 4665 which resulted in further injury and
complete damage of the bike. Many parts of the bike
has been broken and headlights and other things
damaged.

In this context, I beg to state further, that
he is injured, bike damaged, went to Kins Nursing
Home for treatment and currently at home.

I see that for the cause of the vehicle bearing
regn no WB 54 N 0715, the total mishap occurred.
