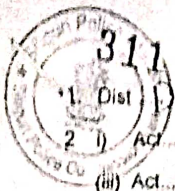

Sir,

In producing herewith one (01) person namely Ajay Giri (M/33), S/O- Lt. Abodh Giri of Tikia Para, 1 No Matangini, Near Rail Gate, W/No - 28, PS. Siliguri, Dist- Darjeeling along with seized articles viz. 12 (twelve ) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 7.2 liters, value Rs 1440/- I ASI Debasish Das presently posted at Siliguri Police Station, Siliguri Metropolitan Police would like to lodged this written complaint against the above noted person that today (10.09.2022) at 22.15 hrs while performing Special Mobile duty, myself along with ASI- Siben sarkar, ASI Rabin Lama CV/622 Ramanath Barman and CV/ 283 Prasanjit Dey had been to Tikia Para, 1 No Matangini area and found that the selling and storing of liquor was going on at the shop of the aforesaid person. Then I cordoned the shop with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the shop. On being search of his shop in presence of available witnesses the above noted seized articles are found inside his shop. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the place the persons who were having liquor at the shop manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 22.45 hrs to 23.05 hrs.

Therefore I pray before your good self that a specific case against the above noted accused person namely Ajay Giri (M/33), S/O- Lt. Abodh Giri of Tikia Para, 1 No Matangini, Near Rail Gate, W/No - 28, PS. Siliguri, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.
