Sir,

In producing herewith one accused person named Tapeswar Routh(45) S/O- Late Prokash Routh , Harijan Busty Diesel Colony ,P.S- Pradhannagar Dist- Darjeeling along with the following seized articles :-

1. 25(twenty five) plastic bottles of 70 up country spirit kachi contains added flavor of Mahua each bottle containing 300 ml. blended & bolted by Prakash distillery & Chemical Co (P) Ltd. Bandrijote, Pradhannagar , Siliguri,


I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Tapeswar Routh(45) S/O- Late Prokash Routh , Harijan Busty Diesel Colony ,P.S- Pradhannagar Dist- Darjeeling to the effect that today on 10/09/2022 at 20:45 hrs. received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his house at Harijan Busty ,Diesel Colony in order to sale the same to his design customers without any valid license for his wrongful gain This refers to Pradhannagar P.S. GDE No- 609 date 10/09/2022. Accordingly the fact is informed to you. As per your direction I along with C/992 Majibur Rahaman , CV-992 Jagadish Biswas and CV-242 Rakesh Monger left for Harijan Busty ,Diesel Colony under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the house where he kept illegal alcohol. On arriving there found the above noted person who disclosed his name & identity as noted above who kept the same at his house in conceal position. On searching found 25(twenty five) plastic bottles of 70 up country spirit kachi contains added flavor of Mahua each bottle containing 300 ml .On being interrogation he could not produce any valid documents/license or authority in respect of the said illicit liquor. He also stated that he is doing this liquor business since last few months for her wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 21:15 hrs to 21:45 hrs.. Apart from this local people are very much annoyed for selling the said illicit in said area . On being asked he stated that he kept the same with a view to sale and supply at Harijan Busty, Diesel Colony area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' arrest rules for selling the said illicit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Tapeswar Routh(45) S/O- Late Prokash Routh , Harijan Busty Diesel Colony ,P.S- Pradhannagar Dist- Darjeeling as per proper section of law.
