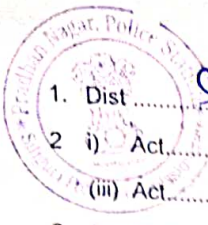

Sir,

In producing herewith one accused person named Muskan Rai (20) S/O- Naren Rai of Lamahatta, Phulbazar Dist- Darjeeling along with the following seized articles :-

1. 14(fourteen) bottles of TUBORG PREMIMUM BEER Original green each bottle containing 650 ml. manufactured by Carlsberg India Pvt.Ltd.

I, ASI Ashit Singha of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against Muskan Rai (20) S/O- Naren Rai of Lamahatta, Phulbazar Dist- Darjeeling to the effect that today on 10/09/2022 at 20:45 hrs. in course of patrolling duty received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his hotel name & style as Durga Hotel, Siliguri Junction in order to sale the same to his design customers without any valid license for his wrongful gain This refers to Pradhannagar P.S. GDE No- 609 date 10/09/2022. Accordingly the fact is informed to you. As per your direction I along with CV-223 Swapan Chettri, CV-128 Ajoy Kumar Sahani and CV-646 Baban Das left for Siliguri Junction under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the Hotel Durga where he kept illegal alcohol. On arriving there found the above noted person who disclosed his name & identity as noted above who kept the same at his hotel in conceal position. On searching found 14(fourteen) bottles of TUBORG PREMIMUM BEER Original green each bottle containing 650 ml. manufactured by Carlsberg India Pvt.Ltd. On being interrogation he could not produce any valid documents/license or authority in respect of the said illicit liquor. He also stated that he is doing this liquor business since last few months for her wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 22:15 hrs to 22:55 hrs.. Apart from this local people are very much annoyed for selling the said illicit in said area . On being asked he stated that he kept the same with a view to sale and supply at Siliguri Junction area without any valid documents. As he has violated the rules and norms of Bengal Excise Act as such I arrested him after observing all sorts' arrest rules for selling the said illicit without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Muskan Rai (20) S/O- Naren Rai of Lamahatta, Phulbazar Dist- Darjeeling as per proper section of law.
