With due respect, I am producing herewith the following articles under seizure.

- I. 12 (Twelve) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ML.
- II. 03 (three) bottles of Kingfisher Strong Premium Beer each bottle containing 650 ML.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 07.09.2022 at 22.35 hrs I received a secret source information that one person namely Durjodhan Mandal S/O Sristi Dhar Mandal of Purba Dhantala, P.S- NJP, Dist.- Jalpaiguri is selling I/D liquor illegally at his shop at Natun Hat area under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 339 dated 07.09.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, SPC left for Natun Hat area under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 22.55 hrs we arrived NJP Hotel Line area, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling Illegal Distilled liquor to regular customers at shop situated at Natun Hat area and hold raid at his shop. but seeing the police party he along with customers were able to fled away. On search the above noted I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from the shop under proper seizure list. The whole process of search & seizure was made in between 23.05 hrs to 23.25 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the accused namely Durjodhan Mandal S/O Sristi Dhar Mandal of Purba Dhantala, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
