The incident took place in front of Group-A Professor's quarter adjacent to SBI, NBMC & H branch at around 2:00 am on 11/09/2022 by 2 boys on a motorcycle WB71B C9896, silver and black coloured Royal Enfield. One of the boys was wearing an olive-green T-shirt. He was driving the bike. He had a partially shaved head. The one who was in the backseat wore a red coloured T-shirt with black-brushed hair. Kindly lodge a file against the said incident and take strict and immediate action.


