

1. That on dated 6th August 2022, the abovenamed persons. 1. Md. Fakre Alam, 3. Shabaaz Alam, 4. Md. Alam came at our office at Dhukuria, near GD Goenka School, with a legal issue and made a promise to pay consideration of sum of Rs. 2,00,000/- (Rupees two lakhs only) i.e Rs. 20,000/- (Rupees twenty thousand only) for four vehicle i.e. Rs. 80,000/- (Rupees Eighty thousand only) and Rs. 17,000/- (Rupees seventeen thousand only) for 7 vehicle i.e Rs. 1,19,000/- (Rupees one lakh nineteen thousand only).
2. That we accepted and agreed to provide legal service to release the vehicle mentioned below for which they made a consideration of Rs10,000/- (Rupees ten thousand only) as an advance payment via gpay being upi transaction id 221881034489 from Mr. Md. Fakre Alam (Bandhan Bank) , on 6th August 2022 at 16.46pm.
3. That the abovenamed persons 1. Md. Fakre Alam 3. Shabaaz Alam, 4. Md. Alam came as the representatives of all the abovenamed persons from 1 to 8, for the release of 11 (eleven) vehicles being registered number- 1.WB70D6000 AND WB74AE5456 with reference to GDE Number- 1280/2022, 2. WB12D5421, WB74BA7037, WB 60Q4842, WB74BD9056, with reference to GDE Number 33/2022, 3 . WB74AY9590, WB74TC1194 (WB74BK0781) with reference to GDE Number 26/2022, 4. WB69A5151 with reference to GDE Number 1236/2022, 5. WB74AV6280 with reference to GDE Number 91-97/2022 and 6. WB74AW7024 with reference to GDE Number 127/2022 which were seized by the Matelli Police Station u/s 102 of CrPC being GDE number- 26/2022, 1280/2022, 33/2022, 91-97/ 2022, 1236/2022, 127/2022.
4. That on dated 08/08/2022 we filed an application for call for report before the Court of Ld. CJM, at Jalpaiguri and on dated 26th August 2022, the Court Ld. CJM Court, at Jalpaiguri was pleased enough to pass the release order and all above mentioned vehicle was released.

5. That as per the promise we fulfilled our part but the saddest part the abovenamed persons did not fulfilled their promise to make the full payment on completion of our legal work .
6. That abovenamed Samser Alam and Avijit Debnath with malafide intention and dishonestly induced the the Duty officer in Charge of Matelli Police Station for delivery and released the vehicle being No - W.B 74 T C 1194 now W.B 74 BK 0781 and WB 12D 5421 , without taking the original release order of the Ld Court which is still lying with us .
7. That we had made frequent request and made a notice to above named persons but no one paid any heed to our cries instead threatened us with dire consequences.

Under this circumstances, I request you to take some necessary action and grant relief by arresting the accused to the earliest so as to avoid us from committing further damage.

for this act of kindness, I shall ever be grateful before your gracious authority.
